LOCAL GOVERNMENT FINANCE SETTLEMENTS: 2004-05 & 2005-06

- Α. CHANGES TO 3-YEAR SETTLEMENT FIGURES
- В. NON-DOMESTIC RATE 2002 -03
- 1. This Circular provides details of the provisional Scottish Executive revenue grant allocations for each local authority for the next 2 years. It builds on the 3 year settlement announced on 4 December 2002.
- These proposals have been sent to COSLA today and will form the basis for consultation between Scottish Ministers and the Convention ahead of the Local Government Finance (Scotland) Order 2004. At the quarterly COSLA / Scottish Executive meeting on 27th November it was agreed that COSLA would respond to the provisional settlement in writing. We are asking COSLA for a response by Friday 16th January.
- As also agreed with COSLA, I will be writing today to Directors of Finance with a draft Local Government Budget. This is a step towards producing a Local Government Budget in February next year. Again, we will be looking for comments on this by 16January 2004.

PART A – SETTLEMENT ALLOCATIONS 2004-05 & 2005-06

- 5. Finance Circular 1/2003, issued in February 2003, provided the final settlement allocations for each local authority for 2003-04 to 2005-06.
- 6. As stated in this circular, these allocations were guaranteed and are not the subject of redetermination during the 3 year settlement period, other than for new burdens for which additional financial provision is being made, transfers into or out of the settlement or for adjustments to agreed 'Level Playing Field' projects. The minimum grant increase floor adjustments set out in Annex C of Circular 1/2003 will not be recalculated.
- 7. There are additionally 3 redistributions the need for which has been agreed with COSLA. Whilst Care Home fees has already been incorporated within these figures, the other two fire pensions and free personal care have yet to be finalised. Details will be confirmed by the relevant SE department once agreement has been reached.
- 8. **Annex 1** confirms the revised all-Scotland aggregate grant totals for 2004-05 and 2005-06.
- 9. **Annex 2** details the agreed additional allocations and transfers on top of the existing guaranteed allocations for next year and the year after. The majority of these have been the subject of separate notification to local authorities, for which references are provided.
- 10. There are also a number of other areas where resources for 2004/05 and 2005/06 are yet to be agreed These include the funding to be transferred from DWP for Residential Allowance cases (in 2003-04 the amount will be £17.899m including a one-off transfer of £0.399m for administration with future years still to be determined) and police partnership monies (£1 million for Police Partnerships in 2004/05; £6 million in 2005/06). In addition, these allocations do not include any resources for Partnership Agreement commitments where the distribution arrangements are still being considered
- 11. **Annex 3** sets out the distribution of the revised distributable Aggregate External Finance (AEF) between authorities and the allocation of the 3 elements of AEF (Revenue Support Grant, Non-Domestic Rates Income and Specific Grants) for each authority. As noted above, the revenue grant distribution arrangements for the 3 year settlement allocations, including population projections, were agreed last year and have not been revised. The distribution arrangements for the new allocations and transfers were discussed at the Joint Ministerial/COSLA quarterly meeting on 27 November 2003.
- 12. The calculations outlined in Annex 3 are broadly as follows. Estimated Service Expenditure (ESE) includes an element of Special Islands Needs Allowance. To the assessments of ESE were added allowances for loan and leasing charges and the floor adjustment. This produces a figure for Total Estimated Expenditure (TEE) for each authority. AEF totalling £7667.721 million was then distributed to produce a uniform difference between TEE and AEF per Band D equivalent property across Scotland. Annex 3 also shows the allocation of the 3 elements of AEF for each authority.
- 13. The methodology for calculating loan charges and support for Public and Private Partnerships (PPP) projects is the same as that set out in Circular 10/2002. However, allocations of PPP support have changed slightly from those given in Finance Circular 1/2003 to reflect changes in PPP project details. The revised total amounts included for loan charge support and PPP support are now £915.349m in 2004-05 and £924.829m in 2005-06.

- 14. In keeping with the move towards simplification agreed previously, the circular focuses on each council's total grant allocation. Separate Grant Aided Expenditure (GAE) allocations for individual services are not identified. Once the final figures are approved through the Local Government Finance (Scotland) Order 2004, the associated circular confirming final figures will give reconciliation details of each new fund.
- 15. **Annex 4** gives a breakdown of individual councils' shares of specific grants as used in the calcula tion of RSG. These are unchanged from Circular 1/2003, other than for an increase to the provision for GAELIC grant for 2003-04 to 2005-06; an increase to the provision for National Priorities Action Fund (NPAF) grant for 2003-04 to 2005-06; and an adjustment to reflect the distribution of the previously unallocated NPAF grant for 2003-04.

PART B - NON-DOMESTIC RATES 2004-05

- 16. The Minister for Finance and Public Services announced his provisional decision on the national rate poundage for 2004-05 on 17 December in a statement to Parliament. The Scottish rate poundage has been set provisionally at **48.8p**, with the small business rare relief supplement (to be levied on larger ratepayers to fund the small business rate relief scheme) set at **0.3p**. An announcement on the final Scottish poundage is expected early next year.
- 17. Scottish Ministers have decided that the Distributable Amount of NDRI for 2004-05 will be £1,895.941 million. The balance of Distributable AEF comprises (a) an estimated total of £655.533 million for specific grants (including Police Loan Charges specific grant) and (b) RSG for the year of £5,116.247 million.
- 18. The Distributable Amount of NDRI incorporates a forecast of net income from non-domestic rates in 2004-05. It draws on councils' estimates of the amounts they will contribute to the pool from NDRI in 2003-04. Included in the calculation are: gross income; expected losses from appeals; the expected in-year cost of the transitional relief scheme; estimated expenditure on mandatory and other reliefs as well as write-offs and provisions for bad debts. Adjustments are also made for amounts carried over from previous years. **Annex 5** shows how the Distributable Amount was calculated.

CAPITAL ALLOCATIONS

- 19. From 2004-05, the existing section 94 capital controls will be replaced with the new Prudential framework. Neil Rennick's letter of 17 April 2003 to all local authority Directors of Finance set out the methodology used for calculating the notional 2004-05 capital allocations for loan charges support with the 3-year local government settlement.
- 20. Details of the capital grants in 2004-05 and 2005-06 are shown in **Annex 6**. Not all of these have been allocated at local authority level councils will be notified separately by the responsible departments within the Executive.

ADDITIONAL ALLOWANCES AND TRANSFERS INCLUDED IN THE SETTLEMENT

This Annex summarises the main transfers and additional allocations for the 2004-05 and 2005-06 settlement, as discussed at the Joint Ministerial/COSLA quarterly meeting on Local Government Finance in November 2003. Figures are given for 2003-06.

McCrone additions: Additional funding of £15.0m/£8.0m/£26.0m is being provided from 2003-04 linked to Modernising the Teaching Profession (Reference: SE: Education Department (Donald Henderson) letter dated 29 July 2003.)

Enterprise Act (Stop Now Orders): £0.440m/£0.881m/£0.881m of additional money is being given from the current year, with reference to the implementation of new Stop Now Orders for consumer protection. (Reference: Local Government Finance (Colin Cummins) letter dated 25 April 2003.)

Rough Sleepers Initiative: £0.5m/£0.5m/£0.5m for future funding of Turning Point project transferred from specific grant allocation to unhypothecated RSG, linked to a local outcome agreement. (Reference: Housing Division (Lindsay Manson) letter dated 11 December 2002)

Care Home fees: Additional provision of £0.422m/£0.422m/£0.422m has been included from 2003-04 and the total amount - £62.646m - has subsequently been adjusted to reflect changes to the distribution data. (Reference: SE: Health Department (Shaun Eales) letter dated 11 July 2003.)

Free School Meals: £3m for 2003-04 to 2005-06 is to be allocated to local government for the costs of changes to the tax credit system. Guidance on the transfers will be issued shortly from SEEducation Department.

National Priorities Action Fund (NPAF): Additional £14.062m/£22.660m/£25.762m will be allocated from 2003-04 within NPAF specific grant. (Reference: SE: Education Department Circular No. 2/2003.)

Gaelic: Additional £0.200m/£0.200m/£0.200m will be allocated from 2003-04 within Gaelic specific grant. (Reference: SE: Education Department (Douglas Ansdell) letter dated 25 March 2003.)

Youth Crime: Provisions of £0m/£3m/£5m was added during Spending Review 2002 and remained undistributed within local government numbers. Subsequently local authorities were informed that this provision would be distributed pro-rata the "Children's Services Development Fund" GAE. (Reference: SE: Education Department (Jackie Brook) letter dated 15 August 2003)

Teachers Pension: Transfer to local authorities from Treasury for local authority teachers' pension scheme of £42.1m/£86.3m/£90.6m (Reference: Local Government Finance (Hilary Pearce) letter dated 5 September 2003).

HB/CTB residual subsidy: £92.800m/£97.333m will transfer out of RSG for 2004-05 and 2005-06 to allow 100% grant funding to be done by Department of Work and Pensions (DWP Housing Benefit and Council Tax Benefit Circular S9/2003, dated 1 December 2003. EXPLANATORY NOTES AND AEF DISTRIBUTION

The calculations are set out in the table at Annex 3. Column numbers are consistent throughout the separate sections for mainland and islands authorities. Columns 1 to 8 relate to the distributions for 2004-05 and 2005-06. Columns 9 to 11 are relevant to 2004-05 only.

- 1. <u>Column 1</u> of the table is the estimated service expenditure of each authority. This column includes Special Islands Needs Allowance.
- 2. <u>Column 2</u> of the table is each authority's share of the Quality of Life funds. The distribution is based on each authority's share of ESE as calculated in circular 10/2002.
- 3. <u>Column 3</u> contains allocations of loan charge support. Capital from current revenue continues to be excluded.
- 4. Column 4 is the assessment of the floor adjustments for each authority.
- 5. <u>Column 5</u> is the total of columns 1 to 4. That is, it is Total Estimated Expenditure (TEE).
- 6. Column 6 is the forecast number of Band D equivalent properties as at September 2003 on which council tax will be levied, as estimated at SR2002.
- 7. Column 7 represents the portion of adjusted TEE which is <u>not</u> supported through AEF. This amount is distributed among authorities in proportion to their share of the national council tax base. This is achieved by a formula:

 (Total adjusted TEE less total AEF) X <u>band D equivalent properties in authority</u> total band D equivalent properties
- 8. Column 8 is the difference between columns 5 and 7 being the total amount of AEF. The total of column 8 is AEF of £7667.721 in 2004-05, (i.e. the total of £7660.521, less NPAF and INSET specific grant, £6.226m, less unallocated loan charge support, £0.651m, plus the amount of specific grant on police loan charges, £14.077m, which are supported by grant but are accounted for outside AEF). AEF distributed for 2005-06 is £7991.732
- 9. Column 9 shows the amount of specific grants (excluding Police CPS, but including Police specific grant loan charges) for 2004-05. A number of specific grants (e.g. police) are paid directly to joint boards. In these cases, for AEF distribution purposes only, the estimated amount for each force or brigade has been broken down on the same basis as is used for the relevant GAEs. Distribution to constituent council level of common police services and police specific grant loan charges as used in the calculation of Police Specific grant for 2004-05, has been based on advice from treasurers of the Police Boards.
- 10. <u>Column 10</u> shows the amount of Distributable NDRI. This has been distributed amongst authorities in proportion to 2002 mid-year population estimates.
- 11. <u>Column 11</u> distributes RSG, being the remainder of AEF after deductions for Specific Grants and NDRI.

CAPITAL EXPENDITURE 2004-05 AND 2005-06

- 1. The introduction of the new prudential regime for capital expenditure in April 2004 will allow local authorities to determine their own level of prudential borrowing according to local needs and priorities.
- 2. Loan Charge Support for capital investment up to and including 2003-04 has been based on the formula and specific consent allocations at the time of each settlement. For 2004-05 and 2005-06 the formula for 2003-04 has been used to establish notional capital allocations on which loan charge support is calculated.
- 3. The prudential regime will mean capital investment in certain services being supported wholly or partially by capital grant. These are for services which were formerly supported by hypothecated consent allocations for specific policy areas, together with certain new ones. Local authorities will be free to invest in capital programmes for these policy areas by supplementing the grants with prudential borrowing.
- 4. From 1 April 2004 Ministerial consent for councils to meet capital expenditure under s94 Local Government (Scotland) Act 1973 will no longer exist nor be required. The arrangements for local authorities to receive the capital grants listed below have been set out by each of the relevant SE divisions which will administer the distribution of the grants.
- 5. Borrowing consents, either from the single formula allocation or from hypothecated allocations for 2003-04, which remain un-used at 31 March 2004 will lapse at that date. However as the unused amount was within the calculation of loan charge support, the support remains in place and councils/joint boards will be in a position to borrow the unused element prudentially on this basis.
