LOCAL GOVERNMENT FINANCE SETTLEMENT: 2005-06, 2006-07 & 2007-08

1. This Circular provides details of the provisional Scottish Executive Aggregate External Finance (AEF) and supported borrowing allocations for each local authority for the next 3 years.

2. These proposals form the basis for consultation between Scottish Ministers and COSLA ahead of the Local Government Finance Order 2005 which is to be debated by the Scottish Parliament in early February 2005. COSLA are invited to respond to the provisional allocations in writing by 14 January 2005.

Three-Year AEF Settlement 2005-06 to 2007-08

4. Ministers' Spending Review 2004 announcement on 29 September 2004 set out the aggregate (AEF) totals for Scottish Executive support to local government for each of the 3 financial years between 2005-2008 (see **Annex 1**). The policy outcomes that the additional Spending Review allocations are aimed at supporting are summarised at **Annex 2**. In addition to the AEF allocations, the Spending Review resulted in other revenue grants to local authorities increasing from £987 million in 2004-05 £1,108 million in 2007-08, and capital grants increasing from £344 million to £465 million over the same period. Details of these revenue and capital grants outwith AEF will be provided shortly in a separate circular.

5. Consultation with local authorities has confirmed that the current system of 3 year AEF settlements has enabled them to improve the planning and delivery of their budgets and services. This settlement therefore again provides local authorities with the stability of 3 year funding allocations.

6. Accordingly this circular provides each local authority with revenue (AEF) allocations for the next 3 years. The allocations are not expected to be subject to redistribution during the 3 year settlement period, although there will be scope to make adjustments for transfers out of or into the grant totals, for example to reflect any new policy initiatives for which additional financial provision is being made. The 3 year revenue allocations will once again provide councils with the certainty to plan their budgets and council tax figures. As for the current 3 year settlement, in response to the allocation of firm 3-year grant figures it is expected that councils will again publish 3 year council tax levels – actuals for 2005-06 and indicative for 2006-07 and 2007-08.

7. Ministers confirmed during their meeting with COSLA elected members on 24 November 2004 that the current 3 year settlement for local government is based on councils increasing council tax by no more than 2.5% in 2006-07 and 2007-08 as a contribution to the overall GAE uplift underlying the settlement. For 2005-06, Ministers have confirmed that they expect council tax rises to be kept as low as possible and have urged local authorities to take all steps possible to improve council tax collection rates to help minimise council tax rises.

Revenue Grant Distribution

8. Ministers agreed with COSLA that the distribution for 2005-06 should remain as calculated for No.14 Order 2004 (Circular 2/2004 gives details) except for any additional resources or transfers of responsibility (Teachers Pensions). For 2006-07 and 2007-08, Ministers and COSLA elected members agreed that the existing formula should be retained and updated to take account of the recommendations of the joint COSLA/Scottish Executive 3-Year Settlement Working Group. A notional 2005-06 distribution was calculated using updated data – e.g. 2003 mid year population estimates, September 2004 school pupil rolls, most recent budget/expenditure information, and all census based indicators were updated using information from the 2001 Census. Secondary indicator coefficients were also recalculated using most recent data. As for the current 3 year settlement, the notional 2005-06 distribution was used as the basis for distribution for years 2 and 3, where applicable calculations are updated using pupil and population projections. These arrangements continue to base the 3-year allocations on the existing needs-based formula.

9. The distribution of the notional 2005-06 and actual 2006-07 and 2007-08 allocations will be confirmed after the end of the formal consultation period between Ministers and the Convention on 14 January 2005. Final GAE calculation detail, including indicator data and the GAE service and sub-service split, for notional 2005-06 and actual 2006-07 and 2007-08 will be published in electronic format following Parliamentary approval of the Local Government (Scotland) Order 2005. Local Authority GAE service and sub-service allocations as at this Finance Circular will be available at <u>www.scotland.gov.uk/stats/gaestats</u> from the 9th of December

10. **Annex 3** sets out the distribution of AEF between authorities. The calculations outlined there were broadly as follows: Estimated Service Expenditure (ESE) includes the Special Islands Needs Allowance (SINA) (see paragraph 10). To the assessments of ESE were added resources for Quality of Life initiatives, allowances for loan and leasing charges; and the floor adjustment (see paragraph 11). This produces a figure for Total Estimated Expenditure (TEE) for each authority. AEF totalling £8,079.720 million was then distributed to produce a uniform difference between TEE and AEF per Band D equivalent property across Scotland, adjusted to reflect Ministers' commitment that the costs of the teachers' pay award in 2006-07 and 2007-08 would be met in full by AEF as a result of this settlement. **Annex 3** also shows the allocation of the 3 elements of AEF for each authority.

11. The SINA payments are contained within ESE and were frozen at 2001-02 levels as a minimum for Eilean Siar, and Shetland. Since 2003-04 Orkney's SINA allocation has increased above the frozen amount. Therefore Orkney, Argyll and Bute, Highland and North Ayrshire receive SINA payments as calculated through the formula agreed after the review of SINA in 2001.

12. To ensure that all councils continue to benefit from the increases in grant arising from the Spending Review, a "floor" is incorporated within the settlement calculation, providing a minimum guaranteed grant increase for each council for each year. The level of the minimum increase has been set with reference to the aggregate increase in distributable grant. The "floor" has been set at 3.4% for 2005-06, 2.0% for 2006-07 and 1.75% for 2007-08 and the effect is set out at **Annex 4**.

13. **Annex 5** gives a breakdown of individual councils' shares of specific grants as used in the calculation of RSG. for 2005-06 and AEF for 2006-07 and 2007-08.

14. The distribution of the actual 2005-06 and notional 2006-07 and 2007-08 allocations will be confirmed after the end of the formal consultation period between Ministers and the Convention on 14 January 2005. Full details of the distribution methodology, including details of the GAE service and sub-service split, for 2005-06 and notional 2006-07 and 2007-08 will be published in electronic format following Parliamentary approval of the Local Government (Scotland) Order 2005.

Loan Charge Support and Supported Borrowing Allocations

15. From 2004-05 the Prudential framework replaced the previous system of Section94 capital expenditure consents. Local authorities are now able to determine the level of capital investment they make, with proper regard however to the Prudential Code for Capital Finance in Local Authorities.

16. The Scottish Executive is continuing to support Local Authority capital programmes through a combination of loan charge support for historic debt and specified levels of assumed new in-year borrowing, and a range of capital grants. Capital expenditure by local authorities, the sources from which it derives, and the future forecasts of expenditure, will continue to be monitored through the Capital Payment Returns in order to feed into national data collection by HM Treasury.

17. Annex 6 provides detail of the loan charge support and related supported borrowing allocations for 2005-06 to 2007-08. The methodology for calculating loan and leasing charges and support for Public/Private Partnership (PPP) projects, known as Level Playing Field Support is also set out. As requested by the 3 year Settlement Group, the floor mechanism has not been re-applied for 2006-07 and 2007-08. Support for loan and leasing charges and the Level Playing Field Support are now identified in two separate columns in Annex 3.

NDR 2004-05

18. Scottish Ministers have decided that the Distributable Amount of NDRI for 2005-06 will be \pounds 1,879.073 million The balance of Distributable AEF comprises (a) an estimated total of \pounds 718.120 million for specific grants (including Police Loan Charges specific grant) and (b) RSG for the year of \pounds 5,464.527 million.

19. The Distributable Amount of NDRI incorporates a forecast of net income from non-domestic rates in 2005-06. It draws on councils' estimates of the amounts they will contribute to the pool from NDRI in 2004-05. Included in the calculation are: gross income; expected losses from appeals; the expected in-year cost of the transitional relief scheme; estimated expenditure on mandatory and other reliefs as well as write-offs and provisions for bad debts. Adjustments are also made for amounts carried over from previous years. **Annex 7** shows how the Distributable Amount was calculated.

Reconciliation with Circular No. 02/2004

20. Councils have indicated in the past that it is helpful to have a reconciliation from one circular to the next. In recognition of this, a reconciliation of AEF 2005-06 from Circular No 2/2004 to Circular No. 8/2004 is included in **Annex 8**.

OUTCOME OF SPENDING REVIEW 2004 - MINISTERIAL POLICY ANNOUNCEMENTS

1. The Scottish Executive's Spending Review announcement on 29 September 2004 acknowledged the vital role of local government in providing services on which people rely (education, health and community care and police) and also services and facilities that improve the quality of life of their local communities. By far the largest proportion of the funding provided through the main local government settlement, including the additional Spending Review allocations, is not ring-fenced or hypothecated. It is for each local authority to establish its spending and investment priorities from its total allocations.

2. This Annex sets out (see table) the GAE uplifts that have been taken into account in reaching the aggregate local government revenue (AEF) allocation totals. Apart from specific grants, these are not ring-fenced allocations. This annex is aimed only at assisting councils in understanding how the settlement totals have been calculated. Provision for 2005-06 was already set as a result of the previous three year settlement, so there have been few changes to the figures for that year (See Annex 8 for details).

Education and Young People

3. For 2006-07 and 2007-08 the Education and Young People portfolio has been increased by the following amounts: Pre-school education - $\pounds 4.9m/\pounds 9.9m$ Surestart- $\pounds 4m/7m$ and Community and Residential Care for Children- $\pounds 2m/\pounds 4m$. $\pounds 7.1m$ currently paid through the Special Educational Needs (SEN) Specific Grant will be transferred to the National Priorities Action Fund in full for 2006-07 and this will be supplemented by a further $\pounds 4m$ in 2007-08. The remaining $\pounds 1.3m$ for SEN in 2006-07 will increase to $\pounds 2.3m$ in 2007-08. The Gaelic line will increase by $\pounds 0.2/\pounds 0.9m$, this includes the increase in specific grant and the consequential additional GAE provision. The GAE line for school bursaries will be removed completely in 2007-08 ($\pounds 7.5m$). The distribution of the resources through AEF for 2006-07 and 2007-08 includes an adjustment to reflect Ministers' commitment that the costs of the teachers' pay award should be met in full by AEF.

Health and Community Care

4. The increase in Care Home Fees (£37.1m/£57.5m) represents the largest increase within the health and community care portfolio. The other main increases are as follows: Increased Number of Elderly - $\pounds16.3m/\pounds42m$; Upskilling Workforce - $\pounds17.0m/\pounds27.0m$; Faster Access to Home Care - $\pounds12.7m/\pounds15m$; Voluntary Sector Care Providers - $\pounds10.3m/\pounds13.6m$; Learning Disability Hospital Closures - $\pounds4.2m/\pounds5m$; and Direct Payments - $\pounds1.8m/\pounds2m$. Both the GAE lines for Pennington ($\pounds3.1m$) and Fishery Products/Shellfish Hygiene ($\pounds0.2m$) will be removed from 2006-07.

Justice

5. The Police and Fire GAEs are increased in total by $\pounds 1.0m/\pounds 3.0m$. This is in addition to the increase in the Police specific grant ($\pounds 21.2m/\pounds 48.6m$) which is covered in the general uplift for pay.

Transport

6. The Roads Maintenance GAE line is increased by £60m/£60m.

Environment and Rural Development

7. The Waste Disposal GAE increases by $\pounds 4.2m/\pounds 18.6m$ and Landfill tax increases by $\pounds 5.7m/\pounds 1.2m$.

Finance and Central Services

8. GAE provision of \pounds 6.0m has been set aside to help fund the Councillor Severance scheme in 2006-07 and \pounds 10.0m has been set aside in 2007-08 costs in connection with the 2007 STV local government elections. However, final allocations for these sums and the distribution of them are still being considered.

Quality of Life

9. "Building a Better Scotland" confirmed the allocation of an additional £180m (\pounds 50m/60/70m) from 2003-06 under the broad themes of Improving the Environment and Supporting Children and Young People. A further £50m has been allocated for each year of the two years 2006-07 and 2007-08 to build on the local service improvements supported by Quality of Life funding consistent with the Executive's commitment to support safer, strong communities. The allocation of these resources is based on each council's share of Estimated Service Expenditure.

Pay and Prices and Efficiency Savings

10. General allowances for pay and prices (excluding teachers, police officers and fire fighters) have been allocated across all service headings (except specific grants).

11. The Executive is looking to local government to play its part in offsetting some of these costs through efficiency savings and as a result an efficiency savings was factored in. However, allocations for education, police and fire have been excluded from the efficiency assumptions leaving an average yearly efficiency saving of 0.7% per year. As a percentage of the overall budget, this represents around 2% over the 3 years 2005-08.

AEF ALLOCATIONS AND EXPLANATORY NOTES TO AEF DISTRIBUTION

The calculations are set out in the table below. Column numbers are consistent throughout the separate sections for mainland and islands authorities. Columns 1 to 9 relate to the distributions for 2005-06, 2006-07 and 2007-08. Columns 10 to 12 are relevant to 2005-06 only.

- 1. <u>Column 1</u> of the table is the estimated service expenditure of each authority. This column includes Special Islands Needs Allowance.
- 2. <u>Column 2</u> of the table is each authority's share of the Quality of Life funds. The distribution is based on each authority's share of ESE.
- 3. <u>Column 3</u> contains allocations of loan charge support. Capital from current revenue continues to be excluded. The figures were calculated as described in Annex 6.
- 4. <u>Column 4</u> contains Public Private Partnership Level Playing Field Support. Capital from current revenue continues to be excluded. The figures were calculated as described in Annex 6
- 5. <u>Column 5</u> is the assessment of the floor adjustments for each authority. The figures were calculated as shown in Annex 4.
- 6. <u>Column 6</u> is the total of columns 1 to 5. It is the Total Estimated Expenditure (TEE).
- 7. <u>Column 7</u> is the estimated number of Band D equivalent properties as at September 2004 on which council tax will be levied.
- 8. <u>Column 8</u> represents the portion of adjusted TEE which is <u>not</u> supported through AEF. This amount is distributed among authorities in proportion to their share of the national council tax base for 2005-06 this is achieved by a formula:

(Total adjusted TEE less total AEF) X

- 9. <u>Column 9</u> is the difference between columns 6 and 8 being the total amount of AEF. The total of column 9 is AEF of £8,079.720m in 2005-06, See Annex 1 AEF for 2006-07 and 2007-08 is £8,343.908 and £8,537.178 respectively.
- 10. <u>Column 10</u> shows the amount of specific grants (excluding Police CPS, but including Police specific grant loan charges) for 2005-06. A number of specific grants (e.g. police) are paid directly to joint boards. In these cases, for AEF distribution purposes <u>only</u>, the estimated amount for each force or brigade has been broken down on the same basis as is used for the relevant GAEs. Distribution to constituent council level of common police services and police specific grant loan charges as used in the calculation of Police Specific grant for 2005-06, has been based on advice from treasurers of the Police Boards.

- 11. <u>Column 11</u> shows the amount of Distributable NDRI. This has been distributed amongst authorities in proportion to 2003 mid-year population estimates.
- 12. <u>Column 12</u> distributes RSG, being the remainder of AEF after deductions for Specific Grants and NDRI.
- 13. It should be noted that Columns 8 and 9 have all been adjusted to reflect the Ministerial commitment to fully fund the cost of the teachers' pay award in 2006-07 and 2007-08.

LOAN CHARGE SUPPORTED AND SUPPORTED BORROWING ALLOCATIONS 2005-06 TO 2007-08

Loan Charge On Local Authority Debt

1. Loan Charges are designed to support the interest payments on Local Authority debt, principal repayments and loans fund expenses. Loan charges amounts are calculated for:

i) actual relevant service debt incurred by councils prior to 1st April 1999

ii) estimated relevant service debt incurred by councils from 1st April 1999 to 31st March 2004 under Section 94 of Local Government Scotland Act, 1973

iii) estimated debt incurred by councils against supported borrowing allocation from 1^{st} April 2004

iv) actual debt incurred by the police and fire services and the Strathclyde Passenger Transport Authority

2. For each category of debt the main components of loan charges are calculated as follows:

2005-06

Loan Charge Support for 2005-06 is as stated in Finance Circular 1/2003.

2006-07 and 2007-08

Loan charges for 2006-07 and 2007-08 are calculated (using a rebased 2005-06) as follows:

<u>Interest Payments</u>: A Scottish average pool interest rate is applied to the average debt. For 2006-07 and 2007-08, the interest rate is 6.13%. This interest rate is compiled from data supplied by PWLB (Public Works Loan Board), CIPFA (Chartered Institute of Public Finance and Accountancy) and HM Treasury.

<u>Principal Repayments</u>: For category i) redemptions are as reported. For categories ii) and iii) an average redemption rate is applied to average debt during the period. This rate is the average all-councils redemption rate for 2003-04. For iv) the rate used for each board is that board's average redemption rate for 2001-02 to 2003-04.

<u>Loans Fund Expenses</u>: An expenses rate is applied to average debt in the period. For 2006-07 to 2007-08, the expenses rate is 0.069%. This is the same rate as was previously used as updated data was not available.

3. In addition, Orkney Islands Council and Shetland Islands Council receive a notional element of loan charges to support their debt free (or previously debt free) status.

Loan Charges For Public Private Partnership Projects

4. In addition to the loan and leasing charges detailed above, loan charges are given to provide a 'level playing field' for Public private partnership projects (PPPs). The methodology for this is described in detail in Finance Circular 16/1997. The total Level Playing Field Support requirement for 2005-08 is as follows:

- 2005-06 £59.955m
- 2006-07 £61.429m
- 2007-08 £61.429m

Total Loan And Leasing Charges Requirement

5. Basic loan and leasing charges requirement is the sum of loan charges across the Local Authority debt types listed in 1.(i) to 1.(iv) (including notional amounts for Orkney and Shetland). The calculated basic loan charges requirement for 2006-08 (excluding LPFS) is as follows:

- 2006-07 £817.454m
- 2007-08 £831.129m

6. These basic totals are then added to LPFS as given in paragraph 4, to give a total basic loan charge requirement (including LPFS) as follows:

- 2006-07 £878.882m
- 2007-08 £892.558m

7. These totals are then adjusted to ensure consistency with the previous early loan charge estimates built into the settlement calculations. Any excess (or shortfall) of support that exists compared to the earlier loan charge is apportioned across the 32 authorities, relative to each authority's share of the basic loan charge requirement (excluding LPFS) as given in part 8 and is provided as other revenue. For 2006-07 and 2007-08 headroom of £87m in 2006-07 and £85m in 2007-08 is included in the final totals. The final adjusted totals are shown below:

- 2006-07 £966m
- 2007-08 £978m

Supported Borrowing

8. For 2006-07 to 2007-08, as for 2004-05 and 2005-06, the total loan charge support to authorities includes an element which represents support, for the period of this settlement, for an assumed level of new capital debt taken out in each year.

9. The previous consent allocation formula has again been used to establish these allocations. As notified in Finance Circular 10/2002, these assumed 'notional' allocations would not have any control on authorities' actual levels of capital borrowing or investment.

10. The table below shows the supported borrowing allocations used to calculate the distribution of the supported borrowing loan charge support <u>for 2006-07 and 2007-08</u>.
