NON DOMESTIC RATES INCOME DATA COLLECTION

1. The purpose of this Circular is twofold: first to inform local authorities about a change is the collection process for Non Domestic Rate Income (NDRI) returns; and second to ask you to help update our records on the contacts in each authority for NDRI returns.

2. From 1 July 2010 Finance and Sustainable Growth – Analytical Unit (FSG-AU), who currently undertake data collections for the vast majority of other local authority returns such as the POBEs and LFRs, will now also collect the regular NDRI returns from local authorities (for (i) the NDRI Provisional Contributable Amount (PCA); (ii) the NDRI Mid Year; (iii) the NDRI Provisional Notified Amount (PNA); and (iv) the NDRI Notified Amount/Audited returns). This should ensure greater consistency in the data collection process. The timetable issued earlier this year by the Scottish Government for these returns remains. You should now routinely send your NDRI returns to Kathleen Cameron (FSG-AU). Her contact details are Kathleen.Cameron@scotland.gsi.gov.uk or telephone to 01431 244 7212).

3. Policy responsibility for NDRI and the General Revenue Grant (GRG) payments will remain as at present. Below is a full list of the responsibilities and contacts for each area.
