1. **LOCAL GOVERNMENT FINANCE (SCOTLAND) ORDER 2016 - SETTLEMENT FOR 2016-17 AND REDETERMINATIONS FOR 2015-16**
2. **LOCAL GOVERNMENT CAPITAL ALLOCATIONS 2015-17**
3. **NON DOMESTIC RATES FOR 2016-17**

1. The Scottish Parliament today debated and approved the Local Government Finance (Scotland) Order 2016. This Order provides the statutory authority to pay the General Revenue Grant (GRG) for 2016-17. The Order also confirms the changes made to amounts payable to each authority for 2015-16 since the 2015 Orders.

2. This Circular provides a summary of the 2016-17 figures (and the revised Revenue allocations for 2015-16) contained in the 2016 Order, which have been revised from those contained in Local Government Finance Circular No. 7/2015 (Version 4).

3. As in previous years the final column in the table at Annex C provides the shares of the Council Tax freeze, but unlike previous years these amounts have not been held back and are included in the overall revenue allocations.

4. The Deputy First Minister and Cabinet Secretary for Finance, Constitution and Economy wrote to all 32 local authorities on 27 January confirming final details of the settlement and inviting local authorities to agree the terms of the settlement.

5. All 32 local authorities have now provisionally signed up, subject to final confirmation when each authority has set its budget, to those terms which will deliver a financial settlement that means the shared priorities which will improve outcomes for local people through health and social care integration and improving educational attainment can be achieved.

6. The accepted funding package for 2016-17 provides:

- An additional £250 million transfer from the NHS to health and social care partnerships to ensure improved outcomes in social care including the facilitation of the Living Wage for every social care worker in Scotland;
- Funding of £88 million to maintain the teacher:pupil ratio at 2015 levels nationally and secure places for all probationers who require one under the teacher induction scheme; and
- £70 million to continue the council tax freeze for a ninth consecutive year.

Part A: Local Government Finance Settlement - Revenue: 2016-17 and changes in 2015-16

8. This Finance Circular sets out the distribution of revenue funding allocations for 2015-16 and 2016-17. **Annex A** of this Circular sets out the all-Scotland aggregate totals for 2015-17 and the changes since Finance Circular 7/2015 (version 4).

9. **Annexes B and C** set out the distribution of the total revenue funding allocation between councils and the allocation of the different elements (General Revenue Funding, Non-Domestic Rate Income, and Ring-Fenced Revenue Grants) for each council for 2015-16 and 2016-17 respectively. The basis behind the grant distribution methodology as explained in Finance Circular 6/2007 has been retained as agreed with COSLA, and additional funding provided as part of Spending Review 2011 to deliver the Scottish Government's 85% floor is included at the end of this process. The explanatory notes contained in **Annex D** explain the basis behind the calculation of the individual council grant allocations for 2016-17.

10. **Annex E** gives a breakdown of the individual council shares of the Gaelic Ring-Fenced grant for 2016-17.

11. The changes to the GRG figures since Local Government Finance Circular 7/2015 are set out in **Annexes F and G**.

Part B: Local Government Finance Settlement – Capital Grants 2015-17

12. There is a change to the 2016-17 distribution of the general capital grant allocation. This reflects the distribution of the 20% of the funding for flood protection to all local authorities. Although not part of the local government finance settlement 2016-17, the £30 million for the Children and Young People Act has also been distributed and included under the heading of other funding. **Annex A** of this Circular sets out the all-Scotland aggregate totals for 2016-17.

13. **Annex H** sets out the capital grants for 2015-16 which remain as set out in Finance Circular 7/2015.

14. **Annex I** sets out the provisional distribution of the Settlement for capital per local authority for 2016-17. Capital grants which remain undistributed are identified as such. The methodologies used to calculate these provisional allocations have been agreed with COSLA. This includes capital grant paid to a local authority in addition to the capital Settlement agreed, but excludes any capital support for schools.

15. **Annex J** summarises the Local Government Finance Settlement for 2016-17.

Part C: Non-Domestic Rates for 2016-17

16. The Distributable Amount of Non-Domestic Rate Income for 2016-17 is confirmed as £2,768.5 million.

17. The following eight pieces of non-domestic rates legislation were laid on 24 February 2016 and apply from 1 April 2016.

17.1. **The Non-Domestic Rate (Scotland) Order 2016.** This Order sets the non-domestic rate poundage of 48.4 pence in Scotland for 2016-17.

17.2. **The Non-Domestic Rates (Levying) (Scotland) Regulations 2016.** These regulations make provision for a poundage supplement (referred to as the Large Business Supplement) in 2016-17 of 2.6 pence on properties with a rateable value in excess of £35,000; and for reductions in non-domestic rates as a result of the Small Business Bonus Scheme (SBBS) for 2016-17.

17.3. **The Non-Domestic Rates (Steel Sites) (Scotland) Regulations 2016.** These regulations provide for rates relief for 2016-17 for steel production at two locations (Dalzell and Clydebridge) in Lanarkshire.

17.4. **The Non-Domestic Rates (Enterprise Areas) (Scotland) Regulations 2016.** These regulations provide for extending from 1 April 2016 up to 31 March 2020 rates relief in respect of Enterprise Areas; and for rates relief for that period for a new Enterprise Area at Biocity in North Lanarkshire.

17.5. **The Non-Domestic Rates (Renewable Energy Generation Relief) (Scotland) Amendment Regulations 2016.** These regulations provide for restricting rates relief in respect of renewable generation in 2016-17 to certain community projects and to property entered in the valuation roll from 1 April 2016.

17.6. The Non-Domestic Rates (Telecommunications and Canals) (Scotland) Amendment Order 2016. This Order provides for any masts or towers eligible for relief under The Non-Domestic Rates (Telecommunication Installations) (Scotland) Regulations 2016 to be given a separate entry in the valuation roll.

17.7. The Non-Domestic Rates (Telecommunication Installations) (Scotland) Regulations 2016. These regulations provide for rates relief from 1 April 2016 to 31 March 2021 for new mobile telecommunication masts or towers located in three pilot areas (two in Arran and one in Cairngorm).

17.8. The Non-Domestic Rating (Unoccupied Property) (Scotland) Amendments Regulations 2016. These regulations amend the non-domestic rate levied on certain unoccupied property from 1 April 2016: unoccupied industrial property is liable for no rates for an initial six months and thereafter for 90% of the rates liability that would have arisen were the property occupied; unoccupied non-industrial property is for an initial three months liable for 50% of the rates liability that would have arisen were the property occupied, and thereafter liable for 90% of that liability. The regulations also continue the Fresh Start and New Start Schemes for 2016-17, respectively supporting occupation of certain long-term empty properties and assisting developers of new properties that are empty when entered on the valuation roll.

18. Copies of the above legislation are published online at www.legislation.gov.uk.

19. As set out above, for 2016-17 the Non Domestic Rate poundage is set at 48.4p and the Large Business Supplement at 2.6p for property with a rateable value over £35,000.

20. A further Local Government Finance Circular providing updates on the Business Rates Incentivisation Scheme will be issued as soon as all the relevant information is available.

The explanation of each of the columns within the tables at Annex C is as follows:

Column 1 – represents the updated on-going service provision and includes the following combined information: (i) the updated Grant Aided Expenditure (GAE) assessments; (ii) the revised Special Islands Needs Allowance (SINA); (iii) each council's individual share of the on-going revenue grants which have been rolled up into the core local government finance settlement; (iv) each council's share of all the baselined redeterminations since Spending Review 2007; (v) the shares of both the £560 million for the council tax freeze over the period 2008-16 and the £70 million for the council tax freeze in 2016-17.

Column 2 – is the new combined total, non-ring-fenced, changes in general provision resulting from Spending Reviews 2007, 2010, 2011, 2013, and 2015 allocated pro-rata to each council's share of GAE plus SINA.

Column 3 – represents the updated share of the loan charges support for historic debt and the same level of on-going PPP level playing field support. The methodology for calculating Loan Charge Support (LCS) and support for Public Private Partnership (PPP) projects (level playing field projects only (LPFS)) is set out on Annex H of Finance Circular 2/2011.

Column 4 – is the main floor adjustment which has been calculated as in previous years by excluding PPP level playing field support. The amount of the on-going revenue grants which have been rolled up into the core local government finance settlement and the council tax freeze amounts, new childcare monies and any new amounts added in 2016-17 were also excluded on the grounds of comparability and stability.

Column 5 – this is the net revenue expenditure recognised by the Scottish Government and represents the sum of columns 1 to 4.

Column 10 – represents the total revenue funding available to each council in that year assuming that Councils accept the full package to be discussed between the Scottish Government and COSLA.

Column 11 – is the 85% floor adjustment which has been calculated to meet the Scottish Government's commitment to ensure that no Local Authority receives less than 85% of the Scottish adjusted average in terms of revenue support at the time of the outcome of Spending Review 2011.

Columns 12 - is the revised total funding including all the changes and the 85% funding floor adjustments.

Column 13 - The final column shows the amount of the council tax freeze allocation on a council by council basis.
