### **Police Negotiating Board Agreement**

1. The Official and Staff Sides of PNB have reached agreement on the revised rates for allowances. Details are set out in the attached memorandum.

#### MEMORANDUM

The Official and Staff Sides of PNB have reached agreement on a pay award for police officers, as set out in PNB circular 2022/03, the revised rates for allowances are as follows:

#### **Additional Disruption Allowance**

With effect from 1 April 2022 the Additional Disruption Allowance is set at £45.18.

#### **Dog Handlers Allowance**

With effect from 1 April 2022 the Dog Handlers Allowance is set at £2,531.41.

#### **Excessive Rest Day Disruption Allowance**

With effect from 1 April 2022 the Excessive Rest Day Disruption Allowance is set at  $\pounds 21.46$ .

#### **Minimum Standards Allowance**

With effect from 1 April 2022 the Minimum Standards Allowance is set at £101.65.

#### **On-call Allowance**

With effect from 1 April 2022 the On-call Allowance is set at £27.03.

### **Overnight Disruption Allowance**

With effect from 1 April 2022 the Overnight Disruption Allowance is set at £67.77.

#### Plain Clothes Allowance

With effect from 1 April 2022 the Plain Clothes Allowance is set at £15.27.
