See previous comments. I would also mention the psychological abuse/stress that these animals suffer. Children and adults see unnatural not natural behaviours in these animals. Animal experts now think that pacing around, head swinging, swaying for instance indicate huge stress and an animal can actually go mad, have a breakdown inflicting self harm and even harm and aggression to other animals/keepers. There is cruelty involved in keeping these animals in such alien surroundings, in goading them to learn and perform. This cruelty can be subtle or blatant, indirect or direct but it remains cruelty. These circuses cannot provide for the unique social, physical and psychological needs of any wild animal. Those who normally live in social groups are often isolated and those who are solitary may be stressed by close proximity to other animals. Cramped conditions are known to be stressful just as they are to humans. They can experience pain, terror, neglect and abuse in the circuses.
