Nor can they provide the versatile surroundings that a tiger needs such as space to roam, trees to climb for the feeling of safety, water to bathe and cool off in. Furthermore, the travelling circuse, the travelling circus to animals' social needs. Lions and lionesses live naturally in a support group or pride but cannot be transported in this way due to the un natural cages and stressful environment they are kept in. Studies have proven that elephants develop psychological issues when

deprived of vital social contact with their families.

Regardless of the species or their needs, the environment in the traveiling circus is not their natural environment and therefore inhibits natural behaviour.
