Yes

Many of the wild animals used in circuses are animals who in nature roam hundreds of miles. In a circus environment they animals are kept in small cages where they are are deprived of everything that comes naturally to them such as choosing a mate, choosing when to eat or hunt, and rearing their young. 20. Comments

Young people learn nothing about animals by seeing them outside of their natural environments, forced to perform demeaning and unnatural tricks. Tigers do not naturally jump through burning hoops just as bears so not normally ride bicycles. The animals learn to perform these stunts through physical punishment. Exposing children to the the circus industry teaches them that it's acceptable to dominate and abuse animals for mere entertainment. This is clearly not a lesson we want to pass onto your young people.

22. Comments

Animals do not exist for our entertainment.

Our understanding of the complex needs of amazing animals such as elephants, zebras and lions has come a long way. We know that bears, monkeys and tigers do not voluntarily ride bicycles, stand on their heads or jump through rings of fire. To perform these meaningless and often physically uncomfortable tricks, trailners use whips, muzzles, builhooks and electric prods. The more we learn about these animals the clearer it is that we can no longer continue to deprive them of their natural instincts and force them to do tricks for human entertainment.
