I refer to your Council's letter and enclosures of 28 June 2016 notifying the above application to Scottish Ministers following consideration by Aberdeenshire Council who were minded to grant planning permission against the advice of Scottish Environment Protection Agency.

Having considered the proposal, Scottish Ministers have decided, in terms of Section 46 of the Town and Country Planning (Scotland) Act 1997 to require the application to be referred to them for determination. Accordingly, a Direction, given in terms of Section 46 is enclosed.

Scottish Ministers have given this Direction in view of the proposed development's potential conflict with national policy on flooding. It is considered that the issues raised would benefit from further scrutiny by Ministers.

Regulation 35 of The Town and Country Planning (Development Management Procedure) (Scotland) Regulations 2013 requires the planning authority to serve notice on the applicant for planning permission of the terms of the Direction, of the reasons for issuing it, that the application has been referred to Scottish Ministers and that the decision of Ministers will be final. In connection with the service of notice, your attention is drawn to regulation 48 of those Regulations which applies section 271 of the 1997 Act. I should be glad if your Council would serve the required notice and let me have a copy. The planning authority is









also required to include a copy of the decision to call in the application on the planning register in accordance with regulation 16 and paragraph 3(d) of Schedule 2.

In terms of the Town and Country Planning (Appeals) (Scotland) Regulations 2013, the application will be submitted to the Directorate for Planning and Environmental Appeals (DPEA) in Falkirk for an examination by a reporter. A disk containing all the application documentation should be sent by your Council, including the attachments to your letter of 28 June 2016 which form part of the application documentation but are not contained on your Council website, to David Henderson, Head of Performance and Administration, 4 The Courtyard, Callendar Business Park, Callendar Road, Falkirk, FK1 1XR as these will be required by DPEA to insert on to their own website. Thereafter, the appointed reporter has been asked to submit a report with recommendations to Scottish Ministers for their consideration and determination.
