### **NUS Scotland Outward**

- NUSUK took part in a students' union study tour **Denmark**, **Sweden and Norway** visiting
  the national student organisations of those countries and some of their member students'
  unions 8 12 January. London.
- 12 14 January saw the second European Staff Network for staff who support elected officers on the international stage, this took place in **Oslo, Norway**.

# SCQF(Scottish Credit and Qualifications Framework)

• The SCQF Partnership recently hosted its 2018 conference titled "The SCQF: **Linking the Learning Journey**" in Glasgow on 22<sup>nd</sup> February. The conference was aimed at all sectors, nationally and internationally, involved in the learner journey and attracted 230 participants from 142 organisations from 13 countries. Showcasing all aspects of the Framework, it also focused on how the SCQF supports Scottish Government policy such as The Learner Journey, Developing the Young Workforce (DYW) and the Commission on Widening Access.

The conference hosted by Paul McKelvie OBE, former Scotland Commissioner to the UK Commission for Employment and Skills, featured a variety of inspirational speakers with John Swinney MSP, Deputy First Minister and Cabinet Secretary for Education and Skills, providing the keynote address. During his speech, Mr Swinney acknowledged the importance of the SCQF to Scottish Government policy saying that, "The Framework is central to our approach to education."

An International Study visit day was held following the conference at the SCQF Partnership Offices in Glasgow, which was specifically designed for international participants, with speakers travelling from as far as **Bahrain and Hong Kong.**

## <u>RSE</u>

• IEP Bilateral Exchange Programme The RSE's International Programme seeks to increase Scotland's research and development connections internationally; and increase the number of world-class science and culture researchers working in Scotland. The RSE administers exchange schemes to provide researchers of at least post-doctoral status with short visit opportunities (normally up to four weeks) to and from Scotland, with a view to developing relationships leading to collaborative projects and levering further research funding from other sources. The deadlines for these schemes are quarterly in late February, May, August and November. Between February 2018 and April 2018, 7 applications were supported by the RSE. Following China and Taiwan workshops, 3 RSE-CASS and 2 RSE-MOST Joint Projects were supported.
