

The National Child Sexual Exploitation Group Terms of Reference

Broad purpose	The National Child Sexual Exploitation Group will work with the Scottish		
of the group	Government on implementation of the National Action Plan to Prevent and Tackle Child Sexual Exploitation and also develop proposals for policy and practice improvement in relation to the Action Plan and within the wider context of Child Sexual Abuse.		
	It is accountable, in the interim, to the Scottish Government's External Advisory Group, under the Child Protection Improvement Programme and will also provide updates at Child Protection Committees Scotland (CPC Scotland) meetings.		
Context	In response to the Public Petitions Committee inquiry into Child Sexual Exploitation in Scotland, a Ministerial Working Group on Child Sexual Exploitation was established and it was tasked to examine the issue of Child Sexual Exploitation and to develop a National Action Plan, by examining the recommendations from the Public Petitions Committee alongside their own expertise in child protection. A National Working Group was established, to support the Ministerial Working Group.		
	A National Action Plan to Prevent and Tackle Child Sexual Exploitation was published in 2014 and updated in March 2016.		
	The National Working Group was given a clear steer by Minister in September 2016, when he wrote to members of the Ministerial Working Group thanking them for their input and dedication to this issue to date, advising he had made a decision to bring the group to a close. His decision was based on the fact that the National Action Plan to Prevent and Tackle Child Sexual Exploitation was in its second iteration, with a clear focus and direction, and he now wished the National Working Group to assume the role of monitoring implementation.		
Membership	Membership of the Group has been drawn from organisations which advise, deliver or support improvement in child protection practices and services in Scotland.		
Remit of Group	The key aims of the group are to:
