	Mr Alderslade is now keen to have a conversation ahead of the Cabinet Secretary giving evidence on the ADT Bill to the Finance and Constitution Committee on 1 March.			
	Airlines UK (formally known as BATA) is a trade body for 11 major UK-registered airlines that operate flights from Scottish airports. Airlines UK supports the Scottish Government's policy on reducing ADT by 50% by the end of the current Parliament and abolishing it when resources allow. Airlines UK responded to the Scottish Government's			
	ADT consultation, is a member of the Scottish Government's ADT stakeholder forum and also gave oral evidence on the ADT Bill to the Committee on 1 February.			
	Mr Mackay has previously met Mr Alderslade on 3 August 2016 (bilateral meeting with airlines) and 12 January 2017 (ADT stakeholder forum meeting).
