Thank you for your letter of 16 December 2016 to Nicola Sturgeon MSP, the First Minister for Scotland, about Russian language qualifications in Scotland. Your enquiry has been passed to me as the matter sits with my ministerial portfolio.

As you note, when Scotland's qualifications were revised to reflect changes in learning and teaching under Curriculum for Excellence (CfE), the Scottish Qualifications Authority (SQA) took the decision to remove a number of courses from the catalogue – including Russian. The decision to remove courses was made entirely on practical grounds, reflecting difficulties in maintaining standards in subjects experiencing consistently low uptake. Qualifications with consistently low candidate numbers have significant infrastructure, teacher training and capacity implications with clear consequences for ensuring standards, exam script and marking consistency from year to year. I would assure you that SQA's decision bore no reflection on the relative merit or value of Russian language or literature – which are considerable.

While Russian language courses were removed from the catalogue I would note that Russian continues to be available to learners through our Modern Languages for Work Purposes Units. Units are available at a variety of stages including SCQF levels 6 and 7, (of a comparable standard to Higher and Advanced Higher). In addition, Russian is also available as part of the Languages for Life and Work Award at SCQF levels 3 and 4. This Award is proving increasingly popular with schools and SQA is currently investigating the possible extension of this qualification to incorporate the more advanced SCQF levels.
