## **Councillor Code of Conduct**

It was agreed that no date for preparing guidance was required in the paper. It would be badged as an SG/COSLA/Standards Commission document. Once finalised COSLA will issue to local authorities.

## Section 75 Agreements

Aberdeenshire are rolling out a Section75 'tracker' which if successful would be shared with other authorities. SOLAR asked for policy/support from the SG on this issue. The Minister asked if the work being undertaken to reduce timescales for Section 75 could be evidenced.

## **Performance**

Section 41 - The Minister explained that now the Bill had been passed a process had to be put in place. Mr Mackay explained he wanted this to be a collaborative process involving the High Level Group and that it should not be an overly bureaucratic process. The PPF and Key Markers provided the base from which to work. HOPS explained that they were already looking at the feedback to look at benchmarking amongst authorities to help them improve. It was agreed that collaboration was the best way forward and COSLA would take a paper on the outcomes of this group to an appropriate COSLA member meeting..

**Action: COSLA** will report to members on the outcome of the HLG discussions.

## Improvement projects

Progress has been slow in some areas but it was hoped now the improvement methodology was in place these need to pick up momentum however the SG reiterated that it still where planning authorities have agreed to help with the projects identified progress needs to be demonstrated.

**Action: SG** to discuss progress with existing partner authorities in the coming weeks.

**Action: SG** to prepare short note on Road Construction Consent project and progress to be issued with note of the meeting.

## Costing of the Planning Service

Malcolm Macleod set out the main strands of this work, three main components of time recording; performance information and detailed financial information. The group agreed that the exercise has provided an objective basis to start with and has revealed that fee income does not cover the cost of the processing of planning applications. Detailed information will be passed to the SG. HOPS would wish to run the exercise again in 2014 and are seeking financial support from the SG for this. It was felt that the information presented was helpful and a breakdown of the variance of costs between different types of authorities (using SOLACE benchmarking groups) could also be provided.

#### Fees

After a discussion on the potential to increase fees it was agreed that a smaller more focussed group would re-convene before 31 March to focus on fees and performance

**Action**: **SG** to provide funding support HOPS for second costings exercise.

**Action: HOPS** to look at the inclusion of 'legal fees' within the exercise to see if these are included or can be drawn out.

**Action: HOPS** to provide evidence of improved performance at the next meeting through the assessment of Red, Amber and Green indicators.

#### Performance

- **1. HOPS** noted that the PPF submission timing would not be brought forward until the 2014/15 reporting period. It would remain as 30 September for this reporting year and then move to a date in June in 2015. This change in timing had broad support and authorities had committed to 'buddying-up' to ensure reports were submitted on time.
- **2. HOPS** talked through Paper A and highlighted that authorities were taking 'red' markings very seriously and that a lot of work was happening in respect to development plans and processing agreements.
- **3. SOLACE** noted that they regularly report on the Group's work. Similarly **SOLAR** have engaged on cross-party working with HOPS and vice-versa.

#### **Fees**

**4. SG** gave a rundown on fees, possible increases and the issues around the cap level. The Minister outlined his view that the fees costings exercise was very useful, the fees gap remains an issue as is comparison with UK fees and that a 5% fee rise on top of a 20% rise must have a connection to improved performance. After discussions around evidence, what was required as part of improved performance, and possible targets, the Minister agreed to increase fees by 5% subject to the Cabinet Secretary's agreement as a recognition of the effort authorities were putting into improving their service, inflation and possible extra resourcing should application numbers increase. Cllr Hagan confirmed that he would take this to COSLA Leaders on 30 May as a private item.

ACTION: The Minister to seek agreement from Cabinet Secretary on 5% increase. If agreed, officials to draft and lay legislation to increase planning fees as soon as practicable.

ACTION: SG Officials and HOPS to develop a shared understanding of performance as described in annual statistical reviews.

5. Discussion turned to other ways to ensure authorities were covering the cost of processing applications. It was suggested that the issue of free applications for Listed Building Consent and Conservation Area Consent be looked at again.









# ACTION: SG officials to provide Minister with paper on number of LBC and CAC being dealt with by authorities and the policy around this. Pre-Application Discussions

6. There was general discussion around charging for pre-application discussions and the differing legal advice provided at a local authority and SG level. There was agreement to take work forward on this but ideally authorities should have the discretion to charge for pre-app and not be obliged to do so, with possible consultation and legislation to follow further down the line. The ability of Key Agencies to charge, or receive part of the fee was also discussed but dismissed. There was however a view that there was a clear expectation agencies should be involved at pre-application stage as they can clearly set out their requirements as part of the application.

ACTION: The legal issue raised about discretion should be explored further. SG, HOPS and SOLAR to take forward at an official level.

#### **AOCB**

7. The issue of timescales and decision making was discussed further. Where additional information was not forthcoming to allow an authority to make a decision on an application then they should consider refusing it rather than drawing out negotiation. There was an acknowledgement however that many planning authorities have a culture of trying to encourage development.

## 1. Feedback on Planning Performance Framework and Annual Report

SG reported on the Annual Report to the group. The group heard that performance levels had improved since the last round of reporting and that generally things were going in the right direction. SG also explained that they had agreed with HOPS some changes to reporting on feedback.

The Cabinet Secretary noted that he was aware of the maximum fee levels for larger applications and the impact these were having on performance and that he would consider looking at fee levels again where it was possible to ensure any increases were ringfenced for the planning service.

## 2. Process to link fees and performance

COSLA welcomed the decision to defer implementation of the penalty clause to 2016 and asked that the penalty clause be put in abeyance indefinitely to enable CoSLA, SOLACE and HOPS to work with those Councils with 'red' identified so that the issues could be addressed. Where it became obvious that the issues were not addressed then the penalty clause would then become active.

The Cabinet Secretary considered there was still the need for pressure to be applied and the penalty clause was a specific tool for this.

John McNairney reminded the group that the creation and agreement of a penalty clause process was a fundamental part of the remit of the High Level Group and that the group needed to decide a final process. The flowchart for the process was agreed, on the basis that there could be further dialogue between SG and authorities at stage 2.

There was a recognition that some of the very lengthy legacy cases which are skewing the performance statistics and that the delays were often not the fault of the authority and the way of reporting statistics was considered. It was agreed that decision making timescales should remain as the only consideration for the penalty clause at the present time.

**Action** – Cabinet Secretary to consider timing of penalty clause.

**Action** – COSLA/HOPS/SOLACE to discuss what more they might do to support poorer performing authorities identified as 'red' and provide a note to the SG on how this might be taken forward.

**Action** – Officials to compare decision making statistics using the median instead of the mean and report back to the Cabinet Secretary's consideration.









# 3. Housing Delivery

The group noted the ongoing work being taken forward around housing delivery. The Cabinet Secretary identified the provision of housing as a priority but there remained a number of barriers to its delivery, specifically the co-ordination of infrastructure.

**Action** – Officials to provide information to the Cabinet Secretary on timescales for changes to CPOs in Scotland.
