

NHSGGC has already undertaken some work relating to its out-of-hours services, such as the centralisation of services at Gartnavel General Hospital (GGH) (after closing centres at the Western Infirmary and Drumchapel); introducing nurses to help reduce demand on GPs both at Primary Care Emergency Centres and for home visits and working with nursing homes to reduce demand. Due to these pressures, NHSGGC has decided to undertake a review of its current out-of-hours service model in light of Sir Lewis Ritchie's review.
