Your request

Response to your request

Request 1

While our aim is to provide information whenever possible, in this instance the Scottish Government does not have the information you have requested. We do not have the information because there are no records of correspondence or notes of meetings between the Scottish Government and the Chinese Government in relation to the pandas at Edinburgh Zoo between 10 June 2017 and the present date. This is a formal notice under section 17(1) of FOISA that the Scottish Government does not have the information you have requested.

Request 2

Between 10 June 2017 and the present date, the pandas were mentioned in two written exchanges between the Scottish Governent and the Royal Zoological Society of Scotland (RZSS). Copies of these email exchanges between Scottish Government officials and the Director of the Giant Panda Programme at Edinburgh Zoo, Iain Valentine are attached at Annex A.

An exemption under section 29(1)(a) of FOISA (formulation or development of government policy) applies to some of the information requested because it relates to the development of the Scottish Government's policy on engagement with China.

This exemption is subject to the "public interest test." Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest is in disclosing information as part of open, transparent and accountable government, and to inform public debate. However, there is a greater public interest in high quality policy and decision-making, and in the properly considered implementation and development of policies and decisions. This means that Ministers and officials need to be able to consider all available options and to debate those rigorously, to fully understand their possible implications.

An exemption under section 38(1)(b) of FOISA (personal information) applies to some of the information requested because it is personal data of a third party, ie names and contact details of individuals, and disclosing it would contravene the data protection principles in Schedule 1 to the Data Protection Act 1998. This exemption is not subject to the 'public interest test', so we are not required to consider if the public interest in disclosing the information outweighs the public interest in applying the exemption. I have also redacted parts of the correspondence due to the subject matter being of no relevance to your enquiry.

Your right to request a review

If you are unhappy with this response to your FOI request, you may ask us to carry out an internal review of the response by writing to Ken Thomson, Director General Strategy and Operations, Scottish Government, St Andrew's House, Regent Road, Edinburgh, EH1 3DG or by emailing DGEconomy@gov.scot. Your review request should explain why you are dissatisfied with this response and should be made within 40 working days from the date you received this letter. We will complete the review and tell you the result, within 20 working days from the date when we receive your review request.


