I tend to agree that use of online/virtual schools of the type outlined in [REDACTED]'s email broadly equates to 'other means' home educated children. And given that the learners and teachers could theoretically be anywhere (i.e. not solely based in Scotland) I also agree that it is probably beyond the scope of Ministers to regulate. I am not aware of any discussions or developments at Education Scotland about this type of online provision.

We are of course interested in the Western Isles' e-Sgoil but this platform is a blended online/offline approach and is being used to supplement the delivery of LA education and broaden access to the curriculum where there are geographical challenges. I would see this as a distinctly different approach to the online/virtual schools referenced below.

I have been asked by the Bill team to provide some advice re virtual schools. You may recall [REDACTED] approached [REDACTED] re registering as an independent school and [REDACTED].

I have received the update from [REDACTED] below which includes the link to his online school. As you will see he is providing the English National Curriculum. It is interesting that he hasn't developed a program providing CfE and his website is very similar to others across the UK. While this delivery model is of interest to us the use of this type of education is a matter for individual parents and indeed they are used by parents who home educate. In accordance with section 30 of the Education (Scotland) Act 1980 parents have a legal duty to provide efficient education suitable to the child's age, ability and aptitude either by causing him to attend a public school regularly or by other means. The Act does not define other means. Of course we know parents send their

children to independent schools and home educate. The former are registered and regulated by Scottish Ministers and the latter has legislation around withdrawal of a child from a local authority school to home educate and there is statutory guidance around this area.

If parents are choosing online/virtual school provision as an 'other means' regulating the quality of such services is surely beyond the scope of Scottish Ministers as potentially the provider could be anywhere in the UK or beyond. Parents may also choose to use a combination of online schooling with other provisions to deliver the practical aspects of their child's education which of course we would define such a parent as a home educator.

While I am not convinced we need legislation I think it will be interesting to see the outcomes achieved by the young people who are educated in this way and if [REDACTED] extends into the delivery of CfE how many will come through the SQA exam system. All a long way off I would suggest but interesting nevertheless. Not sure if there is any research/data available from down south as yet or the view of such provision by DfE.

I am aware of the e-learning project in the Western Isles and other projects in the independent sector who use online learning however has there been any wider discussions with ES colleagues around the development of online schools.

Happy to discuss.

Hi [REDACTED],

many thanks for your email. The project has indeed progressed very well since we last spoke and this week we commenced our first live teaching lessons. The company has been rebranded and it is now named MyOnlineSchooling.com. We have enrolled 8 students to date and have 7 qualified teachers delivering lessons through our virtual classroom. We have a number of other students who will be joining in the coming weeks and there is also significant interest from families overseas in places such as South Africa, Iran, Vietnam, Thailand and Singapore wishing to follow a British education system. Teachers deliver live lessons in a range of curricular areas. All coursework is set by teachers and it is completed electronically by students, returned to their teacher and all work is marked and feedback provided. Parents are able to communicate with their teachers and reports are sent home termly.

The interest in the school has been extremely pleasing with daily enquiries from parents looking for an alternative pathway for their child's education. Upon speaking to parents, it is evident that there are a large number of young people around the UK who are unable to attend school for a number of reasons. Bullying, exclusion, anxiety, social and emotional needs are some of the main reasons that parents are looking for an alternative education. There have also been a number of families who are looking for a distance learning approach as they are too far from schools they have been allocated by local authorities.

The feedback from our first lessons has been exceptional from both students and parents. The lessons have been very engaging and interactive and they allow for focused teaching and learning. Lessons are based on the English National Curriculum and teachers deliver them from set schemes of work.

It would be great to speak again about the project and see whether there is some way that this can be used to support young people in Scottish education.

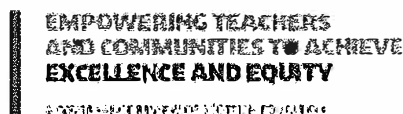
