Dear Deputy First Minister

Thank you for your letter to me of 14 June, as a member of the Curriculum for Excellence (CfE) Management Board. You asked us all for focussed and deliverable ideas of what further actions could be taken to further reduce workload for teachers and young people and to de-clutter and streamline approaches. Please find herewith some initial responses from those of our schools that follow aspects of the CfE and are centres for the SQA National Qualifications.

A key feature of all of our schools, mainstream and additional support needs, is that independence for them indicates autonomy, but not distance or isolation from teaching and learning in Scotland. All of the schools feel the impact of developments in Scotlish education. Some, like the review, design and assessment of the new National Qualifications, have been met with engagement well beyond the proportionate size of the sector (quite unlike the situation in England and Wales).

The primary response of our schools is on the subject of Assessment. Teaching colleagues report spending too much time delivering and marking Unit assessments that for many pupils are low hurdles that need cleared in order to sit the final exam. Indeed, one Head proposed that unit tests for National qualifications at National 5, Higher and Advanced Higher (where there are final SQA examinations), should become optional, while another suggested they should be reduced in number but made more rigourous. Responses have also questioned whether the removal of such assessments would, as has been suggested, devalue the National Qualifications in the eyes of UCAS.

Staff report investing a considerable amount of time on the preparation, delivery and interpreting of "often ambiguous" marking schemes, and then more time on internal verification and then external verifications. Whilst the desire to have attainment recognised at Unit level is well understood, for the most part, these units are seen just as necessary stepping stones towards the more significant Higher course assessments.

The question was asked by one school of "Who values unit assessment passes where a candidate falls the course assessment? Certainly not the candidate. Further education institutions? Employers?". The structure is reported as placing a huge demand on time and resources, and detracts from core teaching and "rich and deep learning" as well as detracting significantly from the time staff have for preparation and marking. The request from one Director of Studies to the CfE Management Board is "to declutter assessments significantly, and to place more trust in schools to prepare pupils appropriately for the external exams."

One Head has outlined to me more revolutionary thinking in terms of capping the pupil/teacher ratio and the school roll size, limiting school inspections and the practice of permanent teacher contracts. They too observed that the Broad General Education phase of secondary schools should be one year (not three). Pupils at the end of S1 could choose to continue with a maximum of 10 subjects and spend the next two years heading towards a Nat 4 or 5 qualification by the end of S3.

Higher courses could then be given two years for completion (rather than the current one) i.e. S4 and S5. S6 should be used for Advanced Highers or mop up of subjects requiring upgrade. This would "remove pupil stress and increase the amount of quality teaching time which is, naturally, more sustainable." Another Head agreed that the three year Broad General Education should be removed and returned to a 2 + 2 + 2 structure so as to allow greater teaching time for National Qualifications and allow pupils to study up to eight subjects at National 5 grade

As you can see, there is no shortage of thinking in our sector on the questions you raise. I also attach a fuller letter recently sent by the Principal of ESMS to the SQA and other Party spokespeople. Our schools would be delighted to discuss the contents of any of these further.

"Our advice would be that it is considered good practice to have at least two members of staff at a school suitably trained for the roles of Child Protection Co-ordinator and Deputy Child Protection Co-ordinator.

As trustees / board members tend not to be at school day-to-day, ideally both CPC and DCPC would be school staff.

Additionally, and separate from the CPC and DCPC roles, HM Inspectors have identified good practice in other schools where at least one trustee / board member (or a sub-committee) has a specific remit to provide challenge to the school's leadership on child protection and GIRFEC compliance and review policy and practice in the school. In these roles, trustees would be made aware of child protection referrals on a regular basis, but not know the names of the young people involved"
