This could be anything that you think is relevant such as the visual impact or economic benefits of the moorings which would be under GEN 7 Landscape/seascape and GEN 2 Economic benefit.

We can accept hard copy maps/chart. The map needs to clearly show the extent of the moorings area so this would need to be marked up.

I had a discussion previously with the Crown Estate who suggested the equipment of the fish farm had been removed. Many thanks confirming this information, much appreciated.

Under Part 4, section 25(1) of The Marine (Scotland) Act 2010 (the Act), Scottish Ministers may require an application for a marine licence to be made in such form as they may determine. Under Part 4, section 25(3) of the Act, Scottish Ministers may require an applicant to supply such information and produce such articles as in their opinion may be necessary to enable them to determine the application. In addition under Part 4 section 25(6) of the Act, if an applicant fails to comply with a requirement made by the Scottish Ministers under this section, the Ministers may refuse to proceed with the application or refuse to proceed with it until the failure is remedied.

I should be grateful if you could make reference to the SNMP and submit an OS or Admiralty Chart which is not copyright in order for us to continue processing your application.
