**Notice of Forthcoming Examination of Unresolved Issues For The Proposed Dundee Local Development Plan
Town and Country Planning (Scotland) Act 1997 Sections 18(4)(B) And 19 (6)
The Town and Country Planning (Development Planning) (Scotland) Regulations 2008**

I am writing to advise you that the above plan was submitted to Scottish Ministers on 13 February 2018 for examination. Scottish Ministers have been informed that you have made a representation about the proposed plan and full copies of your submission have been passed to them. I enclose, for your information, a copy of the notice that has been published in the local press.

The Scottish Ministers appointed Mr Andrew Sikes BA (Hons), DipUD, MRTPI, Mr Steve Field BA(Hons) MRTPI and Mr Timothy P W Brian BA(Hons) DipURP MRTPI to carry out the examination of the plan. The administration of the examination will be carried out by the Scottish Government's Planning and Environmental Appeals Division (DPEA).

Your representation will be considered by the reporter. We have provided the reporters with a summary of the issues that we consider should be assessed at the examination, and a copy of your full representation.

Please note that additional reporters may be appointed to support the speedy delivery of the report.

The lead reporter, Mr Andrew Sikes, will now commence the examination of conformity with our participation statement as required by Section 19(4) of the Town and Country Planning Scotland Act 1997 (as amended). To comply with Section 19(7) of the Act, the examination of the above plan under Section 19(3) of the Act will not commence until the examination of conformity with the participation statement has concluded, or until four weeks from the date of the appointment of the reporter, whichever is the later. Therefore the earliest date upon which the examination of issues raised in representations will commence is 21 March 2018.
