You will note that Condition 2.5 in the letter has been amended, to provide for match funding to apply to local government funding or some private sector funding received by the College.

Following receipt of the signed grant offer, Schedule 1 to the grant offer (Part 2: Payment of Grant), asks the College to submit, by 20 February 2018, an updated monthly profile of expenditure for the year. Hi Clare

We're due to meet [redacted], GCC, Alex Stewart, NJC Finance Director, and Keir Bloomer, NJC Board on Wednesday at 3:30pm. There are no papers, but I've summarised current issues below:

#### **Funding**

We provided £345,000 in 2017/18, with no commitment to provide further funding. SG previously provided £500,000 as a contribution to initial capital and set up cost. GCC have a 5 year commitment to provide £100,000 pa and after discussions with NJC with elected members and officials, turned down a request for further funding this year. [redacted]

#### **Research**

A requirement of our grant is that NJC commission research on the outcomes they are achieving. This has been slow to start and the first deliverables will be late in 2018/19 (well beyond the timescale of the grant). Keir Bloomer is leading on this, and is involved in a panel on 16 April to appoint a PhD student to the role. This will be hosted by Stirling University, jointly supervised by two academics with appropriate expertise. SG will be on the research advisory group.

## Meeting with Newlands Junior College, 28 March 2018

Present : Clare Hicks and [redacted], SG

[redacted] set out GCC's position, that it valued the service that NJC provided to its students but that it had no more financial support to offer in 2018/19 and that it continued to consider NJC lacked a sustainable financial proposal going forward.

AS said that there was due to be a meeting between Jim McColl and [redacted] on 9 April at which NJC would be reiterating its request for financial support from GCC. He said that NJC's proposal remained the same - that local government and central government support each student at NJC at the level of the average cost per secondary pupil, around £6,900.

AS felt that any erosion of the model offered by NJC was likely to undermine what it achieved. The high teacher:pupil ratio, the dedicated headteacher, and the small cohort size were felt to be critical. KB said the 3 things that made a difference at NJC were the quality relationships between pupils and between pupils and staff; an engaging, relevant curriculum; and the continued support offered to alumni. He felt it might be possible to replicate some parts of this for less, but not all.

KB updated on plans for the research study. It included a literature review of a range of interventions and the cost of educational failure; and an empirical study of what NJC has achieved. Interviews to appoint a researcher would take place in April and an interim report would be required for the end of 2018, although this would not be easy. A difficulty would be identifying comparator evidence. [redacted] said that GCC could help with comparative data as it would have data on similar pupils who hadn't gone to NJC.

KB said the public policy question was how much resource should be spent on this group of students, and if less resource was spent, how much less effective it would be. The research should help inform this.

AS noted the original motivation for establishing NJC had been Smith Group Report on young people not in education, employment and training (NEET), aiming to demonstrate what could be achieved in a 5 year pilot. He thought NJC trustees would be keen to continue NJC and the success it had built. [redacted]

CH asked NJC to confirm what date it would make decision to recruit the next intake, and when the research interim report would be submitted. [redacted] said she would confirm an SG appointee to the Research Advisory Group by 20 April.
