First Minister joint statement with President Torra (issued Wednesday 11 July)

The First Minister of Scotland and the President of Catalonia met at the First Minister's official residence in Edinburgh this evening.

It was a cordial meeting aimed at strengthening the ties of friendship between Scotland and Catalonia. Both leaders discussed the challenging and complex political situation in Catalonia, and agreed that the way forward for Catalonia must be through peaceful and democratic solutions involving dialogue between the Spanish and Catalan authorities, respecting the right to self-determination of the Catalan people.

Both leaders agreed that in 21st century Europe issues of self-determination must ultimately be addressed through democratic referendums. The terms of such referendums should be agreed between both parties and have corresponding international recognition.

The 2014 Scottish independence referendum agreed between Edinburgh and London is the best example of such a process, underlining the fact that issues of constitutional sovereignty should always be resolved through peaceful and democratic means.

Annex A

Catalonia update 09/07/18

- On Monday 9 July, Spanish Prime Minister Pedro Sanchez met President Torra for the first time, in a move that may indicate a softening of tensions. Sanchez, a Socialist, has taken a less hardline tone on Catalonia than his predecessor Rajoy, whom he replaced in June, but has also made clear he is resolutely opposed to any independence referendum or attempt at secession. It was agreed by both Sanchez and Torra that there will be a further meeting (a positive indicator however small). According to Torra, the tone of the conversation was 'constructive, frank and honest' and there has been an understanding that the Catalan crisis is a political crisis and it has to be dealt with politically. Agreement was reached to reinstate the Bilateral Commission between central government and Catalonia, not used since 2011, the main constitutional body for cooperation between the central government and the Generalitat. They collaborate on affairs that affect Catalonia such as the devolution of certain powers and government functions, and the central government's budget.
- Sanchez, prior to the meeting had made a gesture of goodwill by moving jailed Catalan separatist leaders closer to home but other concessions are unlikely to be announced on Monday after the meeting at the Prime Minister's residence in Madrid.
- Ahead of the meeting, Torra briefed the press that he was seeking to use the meeting with Sanchez to promote a Scottish style referendum on Catalan independence and that if the meeting was useful, he would invite Sanchez for a further meeting in Barcelona in September.
- Professor Clara Ponsatí appeared at Edinburgh Sheriff Court last week for a Preliminary Hearing where the prosecution explained they will be using the Treason Felony Act of 1848 to facilitate her extradition back to Spain, under the offence of "levying war in the realm." An eight day hearing will begin on July 30th to determine if Prof. Ponsati should be extradited from Scotland.
- A German court rejected "rebellion" as grounds to extradite Catalonia's former leader Carles Puigdemont and ordered his release on bail. He could, however, still face extradition on the lesser charge of embezzlement/misuse of public funds. Decisions over these charges have been delayed and the German Courts are expected to give a resolution in the coming weeks.

Scottish Government position on Catalonia:

The Scottish Government supports the right of the people of Catalonia to determine their own future.

- We profoundly regret that the Spanish Government has not proceeded by way
 of dialogue with Catalonia's political leaders and that the issue is now, instead,
 subject to a judicial process.
- The fact that our justice system is obliged to act and will act in accordance with the law in relation to extradition requests does not change those views.
- Under the Extradition Act 2003, Scottish Ministers have no role in the determination of European Arrest Warrants, and no powers to intervene.
- Our police, prosecution service and courts are rightly independent of Ministers and will enforce and administer the law free from influence or interference.
- It is the right of any individual to defend themselves, to oppose their extradition in the courts and to be legally represented in doing so it is vital that the integrity of this process is protected.

Bilateral links

Scotland and Catalonia are both members of a number of policy related groupings, such as:

- The Climate Group and the Under2 MoU Coalition, which are initiatives aimed at tackling climate change.
- **Districts of Creativity**, an international network of 13 of the most creative and innovative regions in the world. At the heart of the Network is the recognition that the creative industries are one of the key sectors of the future and we can create a more prosperous world through harnessing the power of creativity.
- **The Vanguard Initiative** is an initiative at the EU regional level promoting new growth through smart specialisation and is driven by a political commitment made by European regions to use their smart specialisation strategy to boost new growth through bottom-up entrepreneurial innovation and industrial renewal in European priority areas.

Annex B

Edinburgh Agreement process:

- For the 2011 Scottish General election the SNP manifesto contained a commitment to hold a referendum on independence
- In the election on 5 May 2011, the SNP won an overall majority of seats in the Scottish Parliament (69 out of 129). It was accepted that if the Scottish Parliament voted for an independence referendum, the UK Government would not stand in its way.
- On 15 October 2012, the Edinburgh Agreement was signed. The Agreement ensured that the Scottish Parliament at Holyrood was able to deliver a referendum that met the highest standards of fairness, transparency and propriety.
- The Agreement set out that legislation for the referendum would be passed in the Scottish Parliament. The governments agreed that the referendum should:
 - have a clear legal base;
 - o be legislated for by the Scottish Parliament;
 - be conducted so as to command the confidence of parliaments, governments and people and deliver a fair test and a decisive expression of the views of people in Scotland and a result that everyone will respect
- The section 30 Order was agreed by the Scottish Parliament on 5 December 2012 and the House of Commons on 15 January 2013 and House of Lords on 16 January 2013. The Order came into force on 13 February 2013.
- On 21 March 2013 the Scottish Independence Referendum Bill was introduced to the Scottish Parliament, setting the conditions for the referendum and for it to be held on 18 September, 2014. The Bill was passed by the Scottish Parliament on 14 November 2013

Catalonia T&I Briefing

Minutes:

The First Minister welcomed President Torra and his colleagues to Edinburgh.

The President and First Minister discussed the challenging and complex political situation in Catalonia. They agreed that the way forward for Catalonia must be through peaceful and democratic solutions involving dialogue between the Spanish and Catalan authorities, respecting the right to self-determination of the Catalan people.

Both leaders expressed a desire to explore economic, trade and cultural opportunities, to further strengthen ties between Scotland and Catalonia. First Minister noted that SDI were already engaging with representatives from Catalonia and that a new post in Barcelona would help to strengthen this work. Ms Mas congratulated the First Minister on the establishment of the Scottish National Investment Bank, she indicated Catalonia would be happy to share its experiences from the establishment of the National Promotion Bank.

The President extended an invite to the First Minister to visit Barcelona, the First Minister indicated she would be delighted to do so.
