I'm writing in relation to your Freedom of Information request for communication between the Race Equality Advisor and internal and external stakeholders. This post has been held by Kaliani Lyle since November 2016 to date. Because of the nature of this role we would need you to change the focus of your request in order to proceed.

You've requested the following information:

- All communication between the Race Equality Advisor and the Scottish Government during her time in post, including notes/minutes of meetings
- All communication between the Race Equality Advisor and external organisations and individuals during her time in post, including notes/minutes of meetings

Because the role of Race Equality Advisor is independent to Scottish Government (SG) neither they, nor their secretariat, are subject to FOISA and SG does not hold information on communication between them and other parties. However, we can provide on behalf of SG:

communication between SG and Ms Lyle (this may not be exactly the same as the Advisor holds).

• official notes and minutes of meetings

However, because the information requested could be held across many parts of SG, we have estimated that it would be likely breach the limit of costing over £600 to provide a response. This would then exempt us from providing the information.

With this in mind, if you'd like to request information in respect of what SG holds you may wish to consider narrowing the focus of your request? That would allow us to proceed with collating the information for you. Some information that might help narrow the scope would be:

- Is there a particular date range?
- Is there a specific subject you're looking for communication on (eg in relationship to the development of Race Equality Action Plan)
- Are there any particular departments in SG that you're interested in knowing if there was communication with? Might be helpful to suggest the most likely parts that would hold information

You can also contact Ms Lyle to request any information she holds, but she is not obliged to provide it. You can contact Ms Lyle via her secretariat on: raceadvisersecretariat@gov.scot

Please let me know if you're happy to amend the scope of the FOI or if would prefer to withdraw if. If you have any questions please don't hesitate to contact me.

I also doubt we could answer the second part within the cost limit – but think we should consider whether we actually hold it as it may require skill/complex judgement to extract it, in terms of quidance from commissioner:

Public authorities are not required to create information in order to answer a request. There's a distinction between creating new information, and compiling information. Where a request can be answered by compiling information from readily-available resources held by the public authority, this is not the same as creating new information. However, if collation of the information would require skill and complex judgement, the information is not held.

I wonder if you can assist? We're in the position of requiring to ask Mr McEnaney to narrow the scope of his request. By way of background Mr McEnaney submitted an FOI on 20 June and we refused it on cost grounds. Request and our response below:

In our response we refused the request on cost grounds and we provided the example of the breadth of the trawl of information required by citing a senior civil servant working across government. We also advised Mr McEnaney to narrow the information request down to the FOI unit.

He has responded by splitting the requests into 2 separate FOI's and omitting senior civil servants. It still requires an SG wide trawl.
