Subject: Energy Bill Cost Average corrections

Hi there

On the Scottish Energy Statistics Hub there is a breakdown of domestic energy bills by local authority area.

We believe that it is misleading/incorrect to add both the average electricity bill to average gas bill to arrive at a average total bill. It is largely true but for some local authority areas the proportion of households with access to a gas supply is considerably lower than elsewhere in Scotland.

In the Western Isle about 1500 households have gas out of approx. 15000 households. Therefore the average electricity bill is high as the majority of households have electric heating. For those with gas heating their electricity consumption is likely to be lower vs electrically heated homes. This is also true in other areas with large numbers of households offgas including Argyll and Bute. Your table suggests that Argyll and Bute has the highest average bills but this is only because two averages have been added as if all had equal access to each power source. The information also only relates to regulated dual fuels and does not include any information on oil/lpg or solid fuels. It is misleading to say that these are average Scottish energy bills. These at best are average dual fuel bills.

There should not be an addition of the two values made where gas is not the vast majority of the heating source in a local authority area.

I hope you are able to correct this or provide a warning about the conclusions that could be drawn. I am aware that the media have picked up on the chart but are not able to interpret this correctly.
