We unequivocally condemn the abhorrent terrorist actions of Hamas.

- The hostages taken by Hamas must be released immediately and unconditionally. Hamas missile attacks must cease immediately.
- Israel like any other country has a right to protect itself and its citizens from terror. In exercising its right to defend itself, Israel must abide by international humanitarian law.

We welcome the temporary pause in fighting to support the release of some hostages and allow humanitarian aid to enter Gaza. We continue to support an immediate and permanent ceasefire in Gaza

- A ceasefire from all sides is needed to ensure the protection of innocent civilians and the delivery of essential supplies including include food, fuel, water, and medical provisions.
- To prevent further deaths, the bombs and rockets must stop, humanitarian and medical facilities must be protected, and civilians must be given unrestricted access to the basic necessities of life, wherever they are.
- There is no justification for the bombing of medical facilities and schools. Humanitarian workers, vehicles and installations including hospitals and schools must be protected under international law.
- We call for essential services including electricity and water to be reestablished in Gaza.

Turkey and Climate

The state-sponsored media report on Ankara's calls for more concrete action against the impact of climate change and the prevention of global warming instead of commitment plans. Türkiye is working to reach a net zero emission goal by 2053 and double its goal to 41% by 2030. It has revised its climate change laws, boosted the size of its preserved areas and expanded its green spaces through ecological corridors. The country is also among the top three in the world with its 551 Blue Flag beaches.

In addition, Türkiye has invested significantly on boosting recycling through the "zero waste project" [spearheaded by first lady Emine Erdoğan]. A U.N-endorsed 'declaration of goodwill', initially signed by the first lady and the U.N. chief, has since been endorsed by the spouses of nearly 30 heads of state, including France, South Korea, Paraguay and Cuba. The initiative primarily, which received recognition last year from UNDP and UN Habitat, aims to align the country with sustainable development principles, prevent uncontrolled waste and leave a "cleaner, developed" country for future generations. Some 150,000 buildings across Türkiye have switched to the zero waste management system, which involves the separate disposal of garbage and recycling practices; and some 17 million people are said to have been educated on adopting zero waste practices since the project's inception in 2017.

Türkiye will host about 45 events during COP28 on different topics including compliance with climate change-related regulations, health, technology, transforming energy resources and zero waste. Transition funding for developing countries will be a key priority. Planning Minister Mehmet Özhaseki will represent Türkiye at the ministerial level.
