GUIDANCE NOTES

The following notes provide guidance on use of the Scottish Government Portfolio Brand logos. Following this guidance will ensure that the correct version of the logos are used, based on size and format.

SUPPLY OF LOGOS EXTERNALLY

Scottish Government logos should only be supplied externally where the use of the logo has been approved. Logos should then be provided solely for that approved purpose as "single use only". Scottish Government logos cannot be retained for subsequent use without the explicit permission of the appropriate business area.

LOGO COLOUR VARIATION

The preferred colour scheme is blue and grey produced using Pantone (PMS) colours or CMYK, however, for flexibility, the logos can also be used in monotone. All master colour pantone references can be found on page 9.

BACKGROUND IMAGES

LOGO EXCLUSION ZONES

Use double the height of the capital letter S from the word Scotland to give an accurate space around the logo. The Net Zero Scotland logo is being used as an example here but the same applies to all logos that are covered by this document.



LOGO SIZING

Consideration has been given to the size of the logos. Please follow the sizing guide shown here. The Healthier Scotland logo is being used as an example here but the same applies to all logos that are covered by this document.

Scotland to measure 29.5mm wide

Minimum size of full logo suitable for use on A5

Scotland to measure 26.5mm wide (This is the minimum size for this logo style)

Reduced logo should be used on A6

Scotland to measure 19mm wide

Minimum size of reduced logo

Scotland to measure 14mm wide

The corporate typeface Clan should be used on all printed communications and publications, the only exception to this is communication material produced in-house on PC-based platforms. In this case, the secondary typeface Arial should be used.
