WORK THEMES 2017/18

- 1. The creation of the Curriculum and Assessment Board represents a rationalisation of the governance arrangements associated with the Curriculum for Excellence. This reflects both the Scottish Government's education reform agenda, including the establishment of the Scottish Education Council, and the requirement to move from considering issues relating to implementation of the curriculum towards identifying areas for further development and improvement. In order to assist with this process, it would be helpful for the Board to identify and agree priority areas to focus on.
- 2. Annex A identifies a set of broad themes for consideration. These are not comprehensive or exhaustive but are detailed here as priority areas which Scottish Government considers the Board could provide expertise and direction on.
- 3. There will also be a number of standing items for the Board to discuss, as required, at each meeting. We anticipate that these will include any relevant papers or proposals from the Scottish Education Council and any pertinent updates from SQA and Education Scotland.
