The Group discussed and **agreed** the aim and primary drivers of their Strategic Work Plan. The document tabled at the meeting would be revised and proposed secondary indicators added before circulation to the Group to consider secondary drivers and examples of change in advance of the next meeting.

The Group noted that the Equalities and Human Rights Commission and Children and Young Peoples' Commissioner had written to the Deputy First Minister on recording and monitoring of bullying.

# 4. Finalisation of Strategic Work Plan

**LGBTIWG 2017003.** 

The Group heard Education Scotland remained committed to improving equalities outcomes. The high quality staff team of Inspectors understand the framework they work under and they evaluate outcomes using the Quality Indicators within HGIOS 4 (How Good is Our School 4). There is an opportunity for the Group to augment the toolkit, by proposing amendments and additions to the challenge questions which the inspection team utilise on inspection visits.

The Group also heard that Education Scotland would be joining Ofsted on an inspection shortly and that there was an equalities workshop for all Education Scotland staff due to be held in December. It was **agreed** to bring findings of the Ofsted inspection back to the Group in due course.

The Group discussed a suggested SG amendment to the work plan regarding recording and monitoring of bullying incidents. The Group agreed that the status quo needed to change and that any new approach required strong guidance and training. It was **agreed** that any new approach would require to be reviewed and evaluated to ensure it was helping children and young people. SG noted that some members of the group had concerns with a non-mandatory approach to recording and monitoring. It was **agreed** the Scottish Government would provide a paper for the Group ahead of a discussion at the next meeting where the Group can conclude its thoughts.

Further comments on specific items of the Plan would be submitted by Group members.

#### 5. Use of GLOW and Yammer

**LGBTIWG 2017010.** 

It was **agreed** to seek a demonstration of GLOW and Yammer for a future meeting. It was also noted there were issues around access to these systems due to security clearance restrictions. There were other closed Group options available to the Group but GLOW usage was increasing among teachers.

6. Update on the draft refreshed anti-bullying strategy, Respect for All: The National Approach to Anti-Bullying for Scotland's Children and Young People

LGBTIWG 2017008. LGBTIWG 2017009. The SG presented to the Group on the refreshed national guidance for schools and local authorities.
