

Data Delivery Group Terms of Reference

Ambition:

To develop a High Level Delivery Plan (HLDP) for the Data Vision for Scotland that reflects work being taken forward by partners across Scotland.

Remit:

To oversee the development of the HLDP and its delivery.

Accountability:

The group will report to the Central Government Digital Transformation Board overseeing the delivery of Scotland's 2017 Digital Strategy.

Ways of working:

- The DDG will meet twice during the development of the HLDP (early 2019) and then every three months after that; the frequency of meetings will be kept under review.
- Members of the group provide advice representing specific organisations or constituencies.
- The group can commission task and finish groups to deliver specific projects that contribute towards the group's aim.
- The group will receive progress delivery reports, planned activity, and updated risk registers every six months
- Papers will be sent around a week ahead of the meeting. Following the open government approach, papers will also be published on blogs and gov.scot, and open engagement in policy development will be encouraged via other digital methods.
- On very rare occasions where a matter is discussed in the DDG in confidence members are expected to maintain confidentiality until the group approves disclosure.
- For a meeting to be quorate there should be at least 10 members present, including the chair.

Attendance:

Members are expected to attend or dial-in to all meetings, and are asked to advise the secretariat if need to offer apologies for a meeting and are/are not nominating an appropriate representative to attend in their place.
