#### **Meeting summary**

#### **High Level Planning Performance Group updates**

Alison shared information on the peer review event for the Planning Performance Frameworks set to take place in September. She encouraged others to feed into this as an opportunity to comment on aspects of the planning system as well as the frameworks themselves. She stressed the importance of having expert feedback on how the agencies responded to the lockdown measures.

#### **Joint Customer Survey update**

Alison gave an overview of the survey carried out by Nature Scot with HES. The survey unintentionally was taken at the beginning of lockdown and received 59 responses. It had 68% completion rate, which indicates the survey may have been too long and Fiona said the relatively low numbers could be due to GDPR issues.

Regardless, the results have been helpful and will guide a benchmarking report. Findings from the survey show a lack of awareness around the work of KAG, but it was clear that the group was viewed positively. There was also a feeling that the agencies managed to maintain their services during lockdown.

Deborah Livingstone expressed interest in Transport Scotland's involvement in future customer surveys, specifically on development planning.

#### **Digital Planning Advisory Group**

Katherine attended the second meeting for the Digital Planning Advisory Group in July and saw their report, which made a case for broader digital planning. Scottish Government has suggested KAG make a statement in support of digital planning. Concern was raised about supporting a policy without having had sight of the report beforehand. It was agreed to request further information on the project' and the report's principles beforehand.

#### 3. Sub-group updates

Skills & training / Partner in Planning (Fiona Rice, Nature Scot)

Fiona explained the role of Partners in Planning as a 'one-stop shop' for planning practitioners in research and guidance. Fiona called for Key Agencies to share more work with the portal. Later, she touched on the conference later on in the meeting.

Alison requested to see agency responses to the NPF4 call for ideas and suggested this could be uploaded to Partners in Planning for convenience. Fiona mentioned house all responses are on the Scottish Government website, but it was agreed to share them on Partners in Planning for a broader audience reach.

- Environmental Evidence (Helen Fallas, BGS)
   Helen shared an update despite her absence. The sub-group submitted the Environmental Evidence report to SG PAD which was positively received. She will update when the report is published, it will remain confidential until later. SG are using the report to guide their digital transformation programme. The sub-group also made links to SLC on regional land use strategies to ensure their reports are consistent. SG recommended developing the iRSS (interim Regional Spatial Strategies) work to support RSS needs. Helen will follow up with SG on these matters.
- Vacant and Derelict Land (David Stewart, Scottish Land Commission) David shared an update despite his absence. David will be in touch next month with proposals for an online event to discuss Vacant and Derelict Land and the role of KAG members. David thanked all agencies who made a response in agreeing to take part and nominated experts. Alison pointed out there is a plan to create a sub-group for this and David's meeting will be the initial meeting. Alison stated HES were keen for involvement to bring older buildings into use.
- Planning Performance Reports & peer review (Alison Baisden, HES)
   Alison shared how despite the timeline being knocked back by COVID, she recommended writing a Planning Performance Framework report, nonetheless. A few agencies are not preparing a PPF but gathering what we have is important. Alison invited members to attend the discussion on their PPFs and Peer Review as a good opportunity to feedback on the planning system.
- NPF 4 (Katherine Lakeman, SEPA/All)
   Katherine is discussing a NPF4 workshop with Fiona Simpson and shared how the Development Planning subgroups will restart soon. KAG are members of all 3 groups: Process (Katherine), Scoping (Kate Givan A&DS) and Evidence (HES).

Katherine invited discussion on the recent removal of the presumption in favour of sustainable development. Alison explained the context behind this (see Gladman vs Scottish Ministers). She was broadly in support of the

changes but unsure on unintended consequences with LDP's that are out of date. Alison offered to help with joint response and was keen for other agency perspectives. There was broad support for a response as a principle but raised issues with some industries in green energy to be addressed. Alan will circulate SEPA's draft response and will submit as joint statement if support is general. Alison expressed support of a general agreement towards a plan-led system within the

## **4. Partner in Planning – Support for the upcoming annual conference** Fiona Rice (Nature Scot)

Fiona Rice discussed the annual conference. The last event was well received. Kevin Stewart attended the launch at the Engine Shed. This year will have an online version of the sessions this time due to Lockdown measures. These will be 1- or 2-hour free sessions over 5 days in November. The themes for the sessions will be based on climate change and planning, broken down into 'climate change: an overview', 'carbon conscious places' (led by A&DS), 'green urban areas' (led by Nature Scot), and 'infrastructure and transport' led by HoPS.

Other topics proposed include 'wastewater issues led by Scottish Water, 'Vacant and Derelict Land' led by the Scottish Land Commission, and 'mitigating climate change effects in historic places' led by HES. Fiona is still looking for speakers and hosts for the overview session. Fiona and Susan Rintoul also invited volunteers for other topics and for feedback on the event format

Susan Rintoul and Trevor Moffatt will hold a session to run through logistics and programme for the event with all speakers and hosts in the run up to the event. Alison agreed to feedback about the event to the HES team for speakers and session hosts on climate change in historic places.

## **5. Update on Planning Skills research findings** Fiona Rice (Nature Scot)

Fiona fed back the findings given from the Partners in Planning event. The project is near completion, the full report pending but draft executive summary has been circulated, which is still confidential. Fiona gave an overview of the report findings about the planning sector. There are 1,600 The private sector employs more planners than the public, and its estimated that the sector needs 500 new planners over the next 15 years to cope with the ageing workforce. There is a slight increase in the numbers of graduates. Interviews carried out with KAG partner members and others. There are 3 focus areas: promotion, awareness raising and development. A route map for retention of new planners to create a sustainable supply. Fiona will circulate report once it is available. The report will inform a collaborative approach from the Partners in Planning group across the sector.

### 6. Green Recovery Offer Update

Provided by Kate Givan (A&DS)

Since last meeting there has been lots of activity. The Green Recovery offers was shared in early summer. This led to several initial enquiries for support. There is a wide range of projects from regional spatial strategies to masterplans for housing sites. It takes the pilot work undertaken last year at Forthside, Stirling, and looking to role this out on a wider scale

Indications of a strong appetite from local authorities to have led to a lot of scoping work. Since the letter, a more formalised this offer document has been published which clarifies what is offered and when. For next steps, the sub-group is working out how digital engagement will work in a more structured way, considering other agencies statutory responsibilities.

At Nature Scot is looking at the requests for overlap with their organisations priorities, being led by Ivan Clark.

#### **7. AOB**

#### - Communication Channels

Tim Moss spoke to Katherine Lakeman on how we can expand our reach in response to the survey outcomes and there will be an agreement on the communication process going forward. Alison Baisden asked if we could circulate joint responses on the Scottish Government webpage. This could also be promoted more through the Twitter handle. Alison suggested sharing and reworking earlier slides on the Green Recovery more widely. Kate Givan agreed to discuss this in the Placemaking sub-group next week

#### - Terms of Reference

Katherine Lakeman included this in the agenda to encourage the group to review and suggest updates to the terms of reference document. Quick changes, such as changing SNH to Nature Scot will be made.

#### - Joint Statements

Fiona Rice mentioned upcoming opportunities through Scottish Government initiatives such as the programme for government, NPF4 and new infrastructure strategy. Alison discussed how joint statements are worthwhile but are resource intensive and stressed a need for improving the groups process for this. Alan suggested that responses could be coordinated by a rota or voluntary system, or even an expert agency-led and that the decision for this could be done on an Ad-hoc basis. Tim suggested that 'principles' could be added to the Terms of Reference which could be pulled out to use on quicker responses. Alison suggested we find key contacts from each agency to create a consultations sub-group to pull out what we should lead on. Kate Givan shared how A&DS are trialling an inhouse method with a join meeting to see if this produces snappy responses, but this does not mean responding to each point in a consultation.

Alison shared that HES have drafted a town centre consultation response and invited other agencies to join this. Kate Givan agreed to share A&DS' response.

#### Updated Site Visits Protocol

Alison discussed new protocols to site visits and requested to see what approach other agencies were taking. Currently some agencies require a much higher level of sign off than before, risk assessments and mitigatory measures to prevent the spread of Covid. Several agencies agreed to share with Alison their current protocols.
