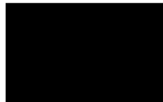

#### Section 1: Summary

During a routine inspection of the above site, a number of lethargic fish were observed in two cages. Five lethargic fish were removed for further examination and subsequent diagnostic sampling.

Histopathology examination revealed tissue alterations consistent with acute pancreas disease (PD). QPCR testing confirmed salmonid alphavirus (SAV), the causative agent of PD. Mild multifocal proliferative gill pathology and presence of occasional amoebic cells suggestive of mild amoebic gill disease was observed. Enteritis was also noted.

#### Section 2: Case Detail

##### Observations

During a routine inspection of the above site, a number of lethargic fish were observed in two cages. Five lethargic fish were removed for further examination and subsequent diagnostic sampling.

Recent mortality numbers had been relatively low across the site, 1.1% over the previous four weeks, with mortalities attributed to a combination of pancreas disease and failed smolts.

External examination of the fish showed a distended abdomen in fish 2, fish 4 and 5 appeared anorexic. No lice were observed on any of the fish sampled.

Internal examination of the fish revealed the presence of clear ascites in fish 2 and 3. Petechial haemorrhaging of the pyloric caeca (PC) of fish 2-4 was observed, there was also a lack of fat noted on the PC of fish 1, 3, 4 and 5. Yellow pseudo faeces was also present in the gut of fish 4 and 5.

**Bacteriology:** Kidney and gill, material from fish 1-5 were inoculated onto appropriate media for the isolation of bacteria.

No significant bacteria were isolated.

**Virology:** Tissue samples were tested for segments of nucleic acid indicative of the presence of the pathogens specified below using real-time PCR (QPCR).

The samples tested negative for infectious haematopoietic necrosis virus (IHNV), infectious pancreatic necrosis virus (IPNV), infectious salmon anaemia virus (ISAV), and viral haemorrhagic septicemia virus (VHSV).

**Histology:** Tissue samples of gill, skin and skeletal muscle, heart, pyloric caeca, pancreas, hind gut, liver, spleen and kidney were taken from fish 1-5. The tissue samples were fixed in 10% neutral buffered formalin.

Histopathological examination revealed the following:

Gill: Mild focal to multifocal interlamellar hyperplasia with occasional spaces (lacunae), some filled with cell debris (F1 & F4). Mild lamellar fusion, epithelial spongiosis and lamellar congestion also noted on the hyperplastic plaques (F1 & F4). Sporadic amoebic cells resembling *Neoparamoeba perurans* were noted in F1 & F4. A copepod-like structure among two gill filaments was noted in F2. Free blood among gill filament and lamellar congestion noted in F5 (likely associated with killing method).

Skin & Muscle: Scattered skeletal white fibre degeneration and rare round shaped skeletal red fibres noted in F4.

Heart: Within normal range

Gut and pyloric caeca: Mild multifocal haemorrhage noted in abdominal adipose tissue of F2 and F4. Marked cell sloughing and marked presence of rod-shaped bacteria that stained Gram negative. These bacteria were associated with eosinophilic amorphous material (likely cell debris) seen within the intestinal lumen and also associated with the epithelial cells of the folds (F1-F5). Adipose tissue showed mild fibrous adhesions likely associated with vaccine administration (F4).

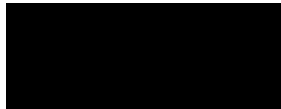
Pancreas: Marked diffuse necrosis of pancreatic acinar cells with little inflammatory response noted in all five fish. F4 showed rare presence of acinar cells.

Liver: Some sinusoidal congestion and mild hepatocyte vacuolation noted in F1 and small foci of haemorrhagic hepatic necrosis noted in F5.

Kidney: Within normal range.

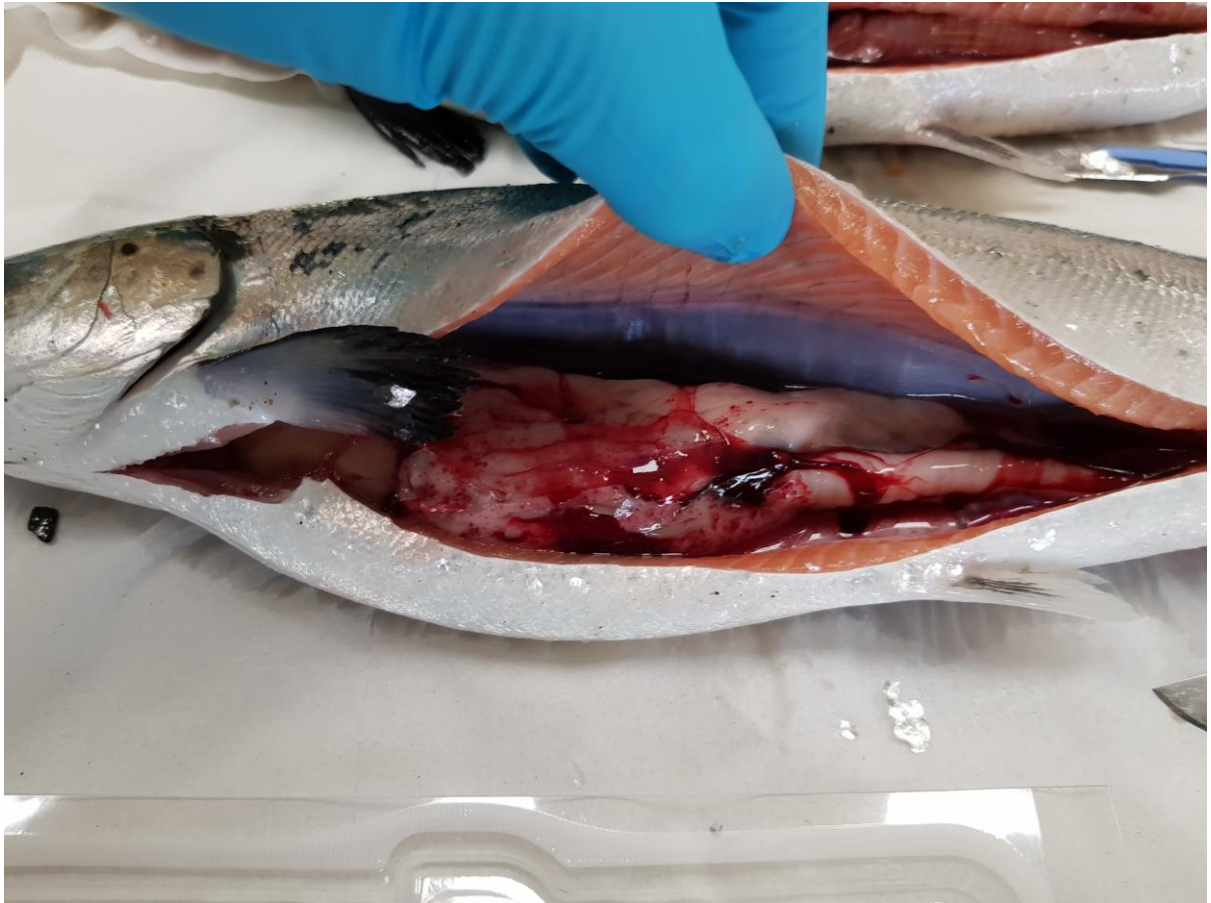

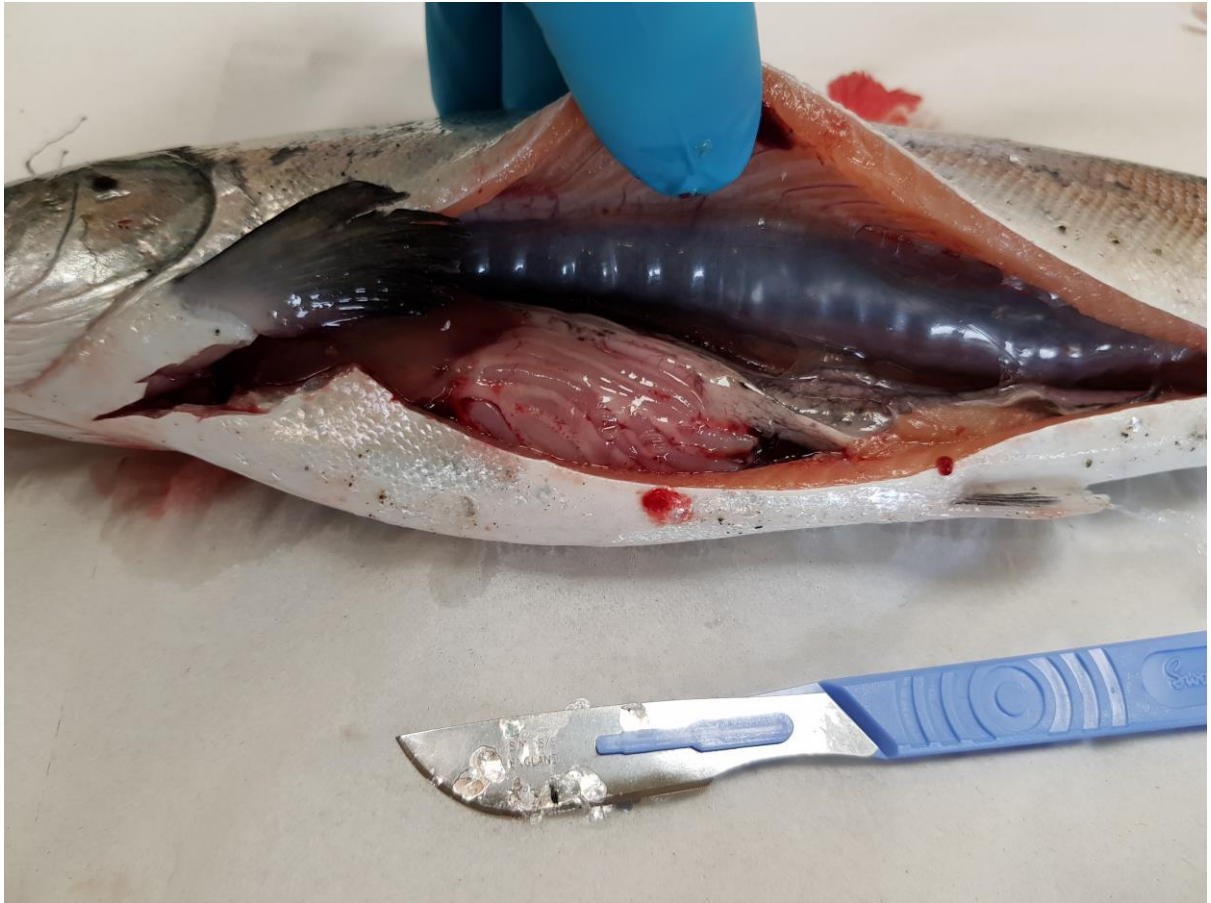
